The Petitioner, Smt. Rita Devi, TGT(Med)) filed CWP No.

10253/2025 titled as, Smt. Rita Devi, TGT (Med) Vs. State of H.P. before the Hon'ble High Court of H.P. against her transfer from GHS, Tunna Distt. (Mnd.) to GSSS, Alsindi Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 07.07.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order. Till the time representation, if any, filed within a period of two days is not decided by the competent authority, petitioner shall not be compelled to join at the transferred station. Pending applications, if any, also stand disposed of."

In compliance to the aforesaid orders passed by the Hon'ble High Court the petitioner was called for personel hearing on dated. 17.07.2025 heard at length. At the time of hearing she stated that she has two son one is 3 years age and the second son is 6 month old. Her mother in law is spine patient and her husband is in police department presently under transfer from Hamirpur nnaur. She has the responsibility of entire family. So, she has requested to adjust her at GHS, Koot u/c GSSS, Sianj Distt. (Mandi) or GSSS, Nandi Distt. Mandi against longer stay by clubbing the previous stay.

From the perusal of record, it is found that Smt. Rita Devi, TGT (Med.) is U/t from GHS, Tunna Distt. (Mnd.) to GSSS, Alsindi Distt. Mandi. At present post of TGT (Med.) are not lying vacant in the above mentioned schools. However, in GHS, Koot u/c GSSS, Sianj Distt. (Mandi) Smt. Praveen Kumari, TGT (Med.) is working since 11.08.2023 and having short stay, but serving within the radius of 30 Km. The continuous services rendered by employees of Education Department within a radius of 30 Km. be considered stay/tenure at one station & such services will be clubbed for calculation of tenure purpose of transfers.

Keeping in view the position stated above, representation of petitioner is considered sympathetically and Smt. Rita Devi, TGT (Med.) is hereby adjusted at GHS, Koot District Mandi vice Smt. Praveen Kumari, TGT (Med.) and vice versa by clubbing her previous tenure (with TTA/JT.) to Smt. Parveen Kumari, TGT (Med.). Keeping in view the position stated above, representation of the petitioner i.e Smt. Rita Devi, TGT (Med.) is disposed of accordingly. With these observations, the representation of the petitioner is considered and disposed of accordingly.
