ORDER

Whereas, Sh. Madan Lal, Headmaster, who is presently working in GHS Dungi, U/C 'GMSSS Sangrah, Distt. Sirmour, H.P. has filed CWP No. 13015/2025- titled as Madan Lal, Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Dungi, U/C GMSSS Sangrah, Distt. Sirmour (Hard area) to nearby his native place in Distt Una, H.P. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 12-08-2025, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

"3. Since it is quite apparent from the pleadings adduced on record that petitioner has already completed normal tenure at present place of posting, which is hard area, coupled with the fact that Transfer Policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer. from hard area to soft area on his/her having completed normal tenure i.e. two winters and three summers, this Court sees no impediment in issuing directions to the respondents to consider and decide the pending representation of the petitioner (Annexure P-3) expeditiously, preferably within three weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of observations made herein above as well as Transfer Policy formulated by the Government of Himachal Pradesh. "

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner has submitted his representation in this office on 22-08-2025, vide which he has requested that 'he may kindly be transferred from GHS Dungi, U/C GMSSS Sangrah, Distt. Sirmour, (hard area) to soft area at GHS Raipur Sahoran, Distt. Una, H.P against vacancy.

On the perusal of the record, it is found that the petitioner is working in GHS Dungi, U/C GMSSS Sangrah, Distt. Sirmour, H.P. since 18-10-2022 which is a hard area and he has completed his normal tenure at his present place of posting. He has given one station of his choice at GHS Raipur Sahoran District Una, H.P. At present the post of Headmaster is lying vacant at GHS Raipur Sahoran, Distt. Una, H.P. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred from GHS Dungi, U/C GMSSS Sangrah, Distt. Sirmour, H.P to GHS Raipur Sahoran, Distt. Una, H.P, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
