**ORDER** 

In the matter of:

CWP No. 7683/2025-titled as Surender Sharma, TGT (Arts) V/s. State of

Himachal Pradesh.

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 7683/2025-titled as Surender Sharma, TGT (Arts) V/s State of H.P. on 09-05-2025, the petitioner was called for personal hearing on 02-06-2025 and appeared before the undersigned on scheduled date. The petitioner has requested for cancellation of his transfer as he is qualified as CTO (Care Taker Officer).

From the perusal of record, it is found that Sh. Surender Sharma, TGT (Arts) who is under transfer from GSSS Gorkhuwala Distt. Sirmour to GSSS Katwar (SMR) by clubbing his previous stay within the radius of 30KM. Sh. Surender Sharma, TGT (Arts) was working at GSSS Gorkhuwala (SMR) since 25.3.2022 and has completed his normal tenure. Further as per Directorate of Higher Education letter dated 20.4.2025 that "ANOs (NCC may not be transferred to non NCC institutions" and petitioner is yet to undergo ANO (Associate NCC Officer) training.

In view of above narrated facts and as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right." Therefore, being a State cadre Government employee, the request of the petitioner is not tenable and hereby rejected. The representation of the petitioner with the present CWP is disposed of accordingly.
