State of H.P. before the Hon'ble High Court of H.P. against his transfer from GSSS, Lower Hareta Distt. (Hmr.) to GMSSS Mamligh Distt. (Sln.). The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 06.06.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"However, having taken note of the adverse familycircumstances of the petitioner, apprised by learned counsel for the petitioner during proceedings of case, present petition is disposed of by reserving liberty to the petitioner to make a detailed a representation to respondent No.2/competent authority for his adjustment at a suitable place, within two days, which in turn shall be considered and decided by said authority within a week, thereafter, taking note of CGP-2013 and also adverse family circumstances of petioner."


