I am directed to refer to the subject cited above and to say that it has been observed by the State Government that certain officers/ officials who have been granted extension in service, re-employment or any other employment are facing issues relating to integrity.

2. In this regard, it is hereby directed that all Administrative Departments shall immediately review the cases of officers/ officials who have been granted extension in service, re-employment and any other appointment. In cases where an officer/ official is found to be of doubtful integrity, the extension or re-employment granted to such officer shall be cancelled with immediate effect.

3. Extension, re-employment or any other appointment shall not be granted to officers/ officials whose integrity is doubtful, in future.



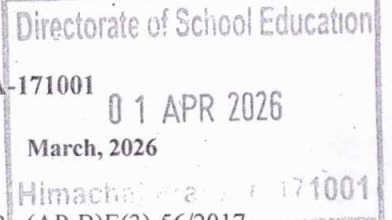


