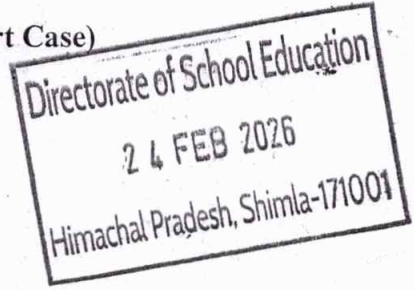

ORDER

Whereas, the petitioner namely Sh.Rakesh Kumar Lect.(History) is working at GSSS Sai Charog (Sln) w.e.f 01.09.2022. He has filed CWP No.19782/2025 titled as Rakesh Kumar vs State of HP. This petition was listed on 15.12.2025 when the same has been disposed of with the directions to respondents as under:-

“Having regard to the afore-submissions, but without examining the merits of the matter, this writ petition is disposed of with a direction to the respondents/ competent authority to consider and decide the aforesaid representation of the petitioner dated 04.10.2025 (Annexure P-1) in accordance with law within a period of four weeks from today. The decision so arrived at shall also be communicated to the petitioner.


The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any.”

And whereas, in order to settle the said court case, petitioner was called to appear in this office for personal hearing on 19.02.2026 and he was present on this date. During the course of hearing petitioner has requested that he is unable to continue his services at present place of posting due to adverse family circumstances and as such he has completed his normal tenure there and further requested that he may kindly be adjusted at GSSS Marhana, GSSS Bharari, GSSS Dangar, GSSS Dadhol, GSSS Kathalag Distt Bilaspur against any longer stay or by clubbing their stay.

And whereas, while examined his representation it is found that although petitioner has completed his normal tenure at GSSS Sai Charog (Sln) but this station is fall in soft area and as per para 12.1 of “Comprehensive Guiding Principals-2013” the transfer of the Government employees, it is clearly mentioned that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/ transfer any employee anywhere in the state keeping in view of the administrative exigencies/ convenience.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a representation of petitioner is being rejected and he will continue his services at ~~GSSS~~ GSSS Sai Charog (Sln). Hence representation stands disposed of.
