Whereas, Sh. Arun Katoch, TGT(NM) presently working in GSSS Lapas, Distt. Mandi has filed CWP.No.15369/2025 titled as Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Lapas, Distt. Mandi to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 23.09.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWPs with the following directions/Order :-

"Since it is apparent from the pleadings adduced on record by the petitioner that petitioner has already completed normal tenure of posting in sub cadre area, coupled with the fact that transfer policy formulated by the Government of Himachal Pradesh enables an employee working in sub cadre area to seek transfer to soft area or one of the stations of his choice after his/her having completed normal tenure of posting i.e. two winter and three summers, this Court sees no impediment in issuing direction to the respondents to consider and decide the representation dated 25.08.2025 (Annexure P-2), of the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate order. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 14.10.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Lapas, Distt. Mandi to GSSS Banseri or GSSS Tattehal or GHS Bharwain or GSSS Jalag, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS Lapas, Distt. Mandi since 24.02.2022. Though the said teacher has completed his normal tenure of three years at GSSS Lapas, Distt. Mandi but at present, vacancies are not available in the above-mentioned schools where petitioner requested for transfer.



ORDER

Whereas, the petitioners in CWP No. 11739/2025 titled as Kalpna (Hindi) Vs. State of HP & ors. Vs State of H.P. have been appointed on contract basis in the year 2015 on fixed contractual emoluments equivalent to minimum of pay band plus grade pay and they have been regularized in the year 2018. Now they have filed court case that after issuance of notification dated 3rd January, 2022, the pay band on which they were offered appointment on contract basis should be revised w.e.f. 01.01.2016 at par with regular employees.

Whereas, the contract salaries in r/o all the contract employees are regulated by Finance Department and on 03-01-2022 State of HP notified Revised Pay Scale Rules-2022 and these rules were made applicable for regular employees of the State w.e.f. 01-01-2016.

Whereas, revised emoluments for contract employees were notified and made applicable w.e.f. 01-01-2022 and contract employees are fixed @ 60% of minimum of pay scale (at the lowest grade, in the regular pay scale). Further, the notification for the grant of arrears on account of pay revision is issued on dated 17-09-2022 by the State of HP qua regular employees which was not applicable for contract period.

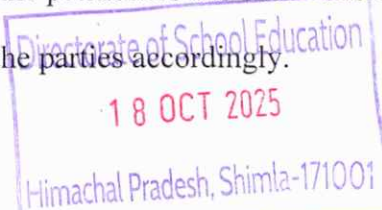
Whereas, the above said court case was listed in Hon'ble High Court on dated 22.07.2025 wherein it has been ordered as under:-


"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the representation of the petitioners in light of Yashwant Singh (supra), expeditiously, preferably within a period of six weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass speaking order thereafter. Pending applications, if any, stand disposed of."

Whereas, the judgment passed in CWP No. 8148/2022 titled as Yashwant Kumar & Ors. Vs State has not been implemented yet and the same has been assailed by Health Department way of filing of LPA."

Now therefore, in view of facts and circumstances as explained herein above the claim of petitioners cannot be accorded as the LPA has already been preferred by Health Department in the leading case i.e. CWP No. 8148/2022 titled as Yashwant Kumar. Accordingly, the case of the petitioners has been considered and rejected.

State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Gumma, Distt. Shimla to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 15.09.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWPs with the following directions/Order :-

In the matter of: CWP. No. 15083/2025-titled as Sh. Hans Raj Guleria, Headmaster Vs. State of H.P. & Others.

Whereas, Sh. Hans Raj Guleria, Headmaster, who is presently working in GHS Sunna, U/C GMSSS Ramshehar, Distt. Solan, H.P. has filed CWP No. 15083/2025- titled as Hans Raj Guleria, Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Sunna, U/C GMSSS Ramshehar, Distt. Solan to nearby his native place in Distt Solan, H.P, against vacancy. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 18-09-2025, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

"3. True it is that it is the prerogative of the employer to post an employee at a particular station, but once transfer policy enables an employee nearing retirement to seek transfer/adjustment at a convenient station, coupled with the fact that petitioner is also not medially fit, this Court without going into the merits of the case, deems it fit to dispose of the present petition, reserving liberty to the petitioner to file representation to the competent authority within a period of one week, praying therein for his transfer/adjustment at a convenient station, as detailed in the petition, which in turn, shall be decided by the competent authority expeditiously, preferably within a period of two weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall 3 afford an opportunity of hearing to the petitioner and pass appropriate order and would also take note of provision contained in the transfer policy with regard to adjustment of an employee nearing retirement, especially when petitioner is due to retire with a period of two Years. Pending applications, if any, also stand disposed of"

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 14.10.2025. He attended the same and submitted his representation in this office on 14.10.2025, vide which he has requested that he is on verge of retirement on 30-04-2027 and has suffering from many health problems. So, he may be transferred from GHS Sunna, U/C GMSSS Ramshehar, Distt. Solan, H.P. to nearby his native place in Distt. Solan, against vacancy .

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Sunna, U/C GMSSS Ramshehar, Distt. Solan, H.P. since 29-07-2022 and has completed his normal tenure at his present place of posting. The petitioner is going to be retire on 30-04-2027. At present the post of Headmaster is lying vacant at GHS Kumarhatti, U/C GGSSS Nalagarh, Distt. Silan, H.P. The petitioner has given willingness for his transfer to the aforesaid school against vacancy. Keeping in view of the above position, the representation of the petitioner is considered and he is hereby transferred from GHS Sunna, U/C GMSSS Ramshehar, Distt. Solan, H.P. to GHS Kumarhatti, U/C GGSSS Nalagarh, Distt. Solan, H.P, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.

ORDER

Whereas, the petitioners in CWP 11576/2025 titled as Praveen Kumar (Geo) Vs State of HP, CWP No. 11578 titled as Yogesh Singh Vs. State of HP, CWP 11662/2025 titled as Pankaj Dhauta and Others & CWP No. 11664 of 2025 titled as Anil Kumar Vs State of HP, CWP No. 10597/2025 titled as Naveen Vs State of HP and in CWP No. 11409/2025 Titled as Bihari Lal Vs. State of HP, have been appointed on contract basis in different years on fixed contractual emoluments equivalent to minimum of pay band plus grade pay and subsequently they have been regularized. Now they have filed court case that after issuance of notification dated 3rd January, 2022, the pay band on which they were offered appointment on contract basis should be revised w.e.f. 01.01.2016 at par with regular employees.

Whereas, the contract salaries in r/o all the contract employees are regulated by Finance Department and on 03-01-2022 State of HP notified Revised Pay Scale Rules-2022 and these rules were made applicable for regular employees of the State w.e.f. 01-01-2016.

Whereas, revised emoluments for contract employees were notified and made applicable w.e.f. 01-01-2022 and contract employees are fixed @ 60% of minimum of pay scale (at the lowest grade, in the regular pay scale). Further, the notification for the grant of arrears on account of pay revision is issued on dated 17-09-2022 by the State of HP qua regular employees which was not applicable for contract period.

Whereas, the above said court cases No. 11576/25, 11578/25, 11664/25 were listed in Hon'ble High Court on dated 21.07.2025 wherein it has been ordered as under:-

"Having regard to the afore-submissions, but without examining the merits of the matters, these writ petitions are disposed of with a direction to respondent No.3/competent authority to consider and decide the aforesaid representations of the petitioners dated 22.06.2025 in accordance with law within a period of six weeks from today. The decision so arrived at shall also be communicated to the petitioners. The writ petitions stand disposed of in the above terms, so also the pending miscellaneous application(s), if any."

Whereas, the court cases No. 10597/25 and 11409/25 were listed in Hon'ble High Court on dated 03.07.2025 and 17-07-2025 wherein it has been ordered as under:-

"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the representation of the petitioners in light of Yashwant Kumar (supra), which has not been interfered till date, expeditiously, preferably within a period of four weeks. Ordered accordingly. In case, petitioners are found to be similarly situate to the petitioner in the aforesaid judgment, they would be extended similar benefits. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioners and pass appropriate orders thereafter."

Pending applications, if any, stand disposed of."

And whereas, the COPC No. 722/2024 in CWP No. 2056/2023 Ghanshyam Dass Vs State the petitioners were also appointed as PGT(IT) now renamed as Lecturer (School New)(Computer Science) in the year 2014 and regularized in the year 2017 and in view of Hon'ble High court of HP orders passed on dated 21.03.2024 and approval conveyed by the Secretary (Education) to the Government of Himachal Pradesh vide letter No. EDN-B-E(3)-

12/2024 dated 17.06.2025 the same have been implemented by this Directorate office order dated 18-06-2025 and the same also been assailed by the department by way of filing LPA.

Whereas, the judgment passed in CWP No. 8148/2022 titled as Yashwant Kumar & Ors. Vs State has not been implemented yet and the same has been assailed by Health Department way of filing of LPA.

Now therefore, in view of facts and circumstances as explained herein above the claim of petitioners cannot be accorded as the LPA has already been preferred by Health Department in the leading case i.e. CWP No. 8148/2022 titled as Yashwant Kumar.

Accordingly, the claims of the petitioners have been considered and rejected.

May inform the parties accordingly.

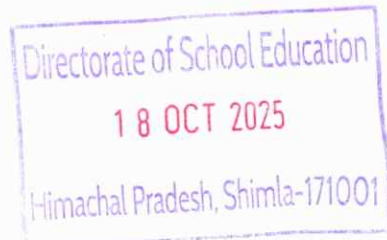
