OFFICE ORDER

In the matter of: CWP No. 13259/2025-titled as Dev Raj, Vs. State of H.P & Others.

Whereas, Sh. Dev Raj, Lect. Biology preferred CWP No. 13259/2025 titled as Dev Raj Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Sach (Pangi) Distt. Chamba to soft area in Distt. Chamba, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 19-08-2025 when the Hon'ble High Court has passed the following orders:-

3. " Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with direction to the respondents/competent authority to decide the pending representation having been filed by the petitioner (Annexure P-1), expeditiously, preferably, within four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon taking note of transfer policy, which enables an employee to seek transfer from hard area to soft area after completion of normal tenure of posting at one place i.e. two winters and three summers. Pending applications, if any, also stand disposed of."

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 15-11-2025. He attended the same and submitted his representation in this office on 15-11-2025, vide which he has requested that he may be transferred from GSSS Sach (Pangi) Distt. Chamba to DIET Chamba, GSSS Udaipur, GSSS Chaned, Distt. Chamba, H.P, against vacancy / against longer stayee.

In the perusal of the record, it is found that the petitioner is working at GSSS Sach (Pangi) Distt. Chamba, H.P since 20-02-2021 (which fall in hard area) and has completed his normal tenure at his present place of posting. One Smt. Madhu Bala, Lect. Biology is working in GSSS Chaned, Distt. Chamba, H.P since 19-12-2020. The petitioner has given willingness for his transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and he is hereby transferred without TTA/JT from GSSS Sach (Pangi), Distt. Chamba to GSSS Chaned, Distt. Chamba, H.P vice Smt. Madhu Bala, Lect. Biology. With TTA/JT to Smt. Madhu Bala, Lect. Biology. The representation of the petitioner is disposed of accordingly.
