ORDER.

In the matter : CWP No. 20807/2025 titled as Ram Kishore, TGT(Med) VS State of H.P. & others.

The Petitioner Sh. Ram Kishore, TGT(Med)) filed CWP No. 20807/2025 titled as, Sh. Ram Kishore, TGT(Med) Vs State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS, Bikram Ka Bag Distt. (Sirmour.) to District Bilaspur. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 29.12.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

*"Though, this Court finds that petitioner was transferred from Government High School, Nesang, Kinnaur to Government Senior Secondary School, Dhar, Shimla on account of his having served in hard/tribal area, but once transfer policy formulated by the Government of Himachal Pradesh enables an employee to seek transfer from hard /tribal area to soft area after his having served in hard/tribal area, he shall be entitled to be transferred to one of the stations of his choice, coupled with the fact that there is nothing on record to suggest that petitioner was posted at Government Senior Secondary School, Dhar, Kinnaur as per his choice, this Court without going into the merits of the case deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the representation dated 03.10.2025 (Annexure P-1), of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate order. Pending applications, if any, also stand disposed of."*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 24.01.2026. The petitioner attended the personal hearing on scheduled date and time. During personal hearing he has requested to adjust him at District Bilaspur.

From perusal of the record, it is observed that Sh. Ram Kishore, TGT (Medical) is working in GSSS, Bikram Bag Distt. Sirmour since 06.05.2025 and haing very acute short stay at his present place of posting. Moreover, GSSS, Bikram Bag Distt. Sirmour falls in soft area.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
