Whereas, Reena Kumari, TGT (NM) preferred CWP No. 8734/2025 titled as Reena Kumari, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMS Balla Ghirtholi, U/C GSSS Jadrangal, Distt. Kangra to GMS Kailashpur, U/C GSSS Makol, Distt. Kangra. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 26-05-2025 when the Hon'ble High Court has passed the following orders:-

*"5. Having regard to the aforesaid submissions and without interfering with the transfer of respondent No.4 under the impugned office order to the place of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner dated 20.05.2025 (Annexure P-4) in accordance with law and applicable transfer policy within a period of one week from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."*

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner has submitted her representation in this office on 02-06-2025, vide which She has requested that She may be adjusted at nearby her native place in district Kangra, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms. .

From perusal of record, it has been found that the petitioner has been working at GMS Balla Ghirtholi, U/C GSSS Jadrangal, Distt. Kangra, H.P and under transfer to GMS Kailashpur, U/C GSSS Makol, Distt. Kangra. One Sh. Naresh Patial, TGT(NM) is working in GSSS Dheera, Distt. Kangra, H.P. since 22-03-2022. The petitioner has given willingness for her transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and She is hereby adjusted at GSSS Dheera, Distt. Kangra, H.P. vice Sh. Naresh Patial, TGT (NM) against longer stay, with TTA/JT to Sh. Naresh Patial, TGT(NM). The representation of the petitioner is disposed of accordingly.
