

ORDER

Whereas, Sh. Gyar Singh, Lecturer (School-New) (English) who is under orders of transfer from GSSS Pota Manal (Sirmour) to GSSS Dibber (Sirmour) issued vide this office order dated 28.4.2025 was filed CWP No.7544/2025 before the Hon'ble High Court against these orders as pleaded that his order was issued on the basis on D.O. note and without any TTA/JT as he has never made any request for his transfer.

The case was listed before the Hon'ble Court on 7.5.2025 when the case was disposed of with the following directions:-

"Looking to the nature of the grievance raised, this writ petition is disposed of by permitting the petitioner to prefer a representation to respondent No.2/competent authority within three days from today. In case, such a representation is so preferred, the competent authority shall consider and decide the same, in accordance with law, within further period of two weeks. The order so passed shall also be communicated to the petitioner".

"Till the decision of the representation, the impugned office order dated 28.4.2025 (Annexure P-1) shall not be implemented qua the petitioner. It is made clear that in case petitioner fails to represent within the aforesaid period, the aforesaid protection granted to the petitioner shall stand automatically vacated".

And whereas, upon passing of above directions, petitioner, Sh. Gyar Singh, Lecturer (School-New) (English) submitted a fresh representation wherein he has given five stations of his choice i.e. GSSS Pota Manal/Shawga Kando/Khadkhan of Distt. Sirmour and GSSS Paban/GGSSS Portmore of Distt. Shimla.

And whereas, that the matter has been examined and found that he has completed his normal tenure at GSSS Pota Manal (Sirmour) and post of Lecturer (English) is lying vacant at GSSS Paban (Shimla) and GSSS Shawga Kando (Sirmour) only.

Now therefore, after taking into account the above facts and circumstances of the case, representation of petitioner is considered sympathically and the petitioner i.e. Sh. Gyar Singh, Lecturer (School-New) (English) who is under orders of transfer from GSSS Pota Manal (Sirmour) to Dibber (Sirmour) is being adjusted at GSSS Paban (Shimla) against vacancy as per his request without TTA/JT.

With these observations, representation stands disposed of.

ORDER

Whereas, Smt. Sunder Lata, Lecturer (School-New) (English) who is under orders of transfer from GSSS Karsog (Mandi) to GSSS Kutahchi (Mandi) issued vide this office order dated 02.05.2025 was filed CWP No.7860/2025 before the Hon'ble High Court against these orders as pleaded that she has not completed her normal tenure at present place of posting and further submitted that she herself is suffering from neurology problems and her mother-in-law is old aged and cancer patient also and her husband is working as AGM (BSNL) and posted in Gujrat and there is no one to look after my mother-in-law accept me.

The case was listed before the Hon'ble Court on 13.5.2025 when the case was disposed of with the following directions:-

"Having regard to the above submission, but without interfering with the transfer of respondent No.4 under the impugned order, this writ petition is disposed of by permitted the petitioner to prefer a representation to respondent No.2/Competent Authority for her suitable adjustment. In case such a representation is made within five days, the same shall be considered and decided by the respondent No.2/Competent Authority, in accordance with law and as per applicable transfer policy, within seven days thereafter. Copy of order so passed, be communicated to the petitioner".

And whereas, upon passing of above directions, petitioner, Smt. Sunder Lata, Lecturer (School-New) (English) submitted a fresh representation wherein she has requested to modify her transfer order to GSSS Churag, Distt. Mandi against vacancy in view of her adverse family circumstances.

Now therefore, after taking into account the above facts and circumstances of the case, representation of petitioner is considered sympathically on medical grounds and the petitioner i.e. Smt. Sunder Lata, Lecturer (School-New) (English) who is under orders of transfer from GSSS Karsog (Mandi) to GSSS Kutahchi (Mandi) is being adjusted at GSSS Churag (MND) against vacancy as per her request without TTA/JT.

With these observations, representation stands disposed of.
