**"ORDER"**

10 JUN 2025

Whereas the petitioner Sh/ Smt. Rajnesh Kumar, Lect./Lect.(SN) Physics is working at GSSS Somakothi, Distt. Mandi w.e.f. 04.05.2021 & as such his stay is complete. Feeling aggrieved he filed CWP No 4644/2025 titled as Rajnesh Kumar Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 01.04.2025 when the same was finally disposed with the directions to respondents as under:-

"Petitioner"s case is that as a Lecturer (Physics), the petitioner has completed much more than his normal tenure at GSSS Somakothi, Distt. Mandi, H.P, whereafter he furnished a representation on 23.02.2025 (Annexure P-6) to respondent No. 1 seeking his transfer. Petitioner"s grievance is that the aforesaid representation has not been decided as yet by the competent authority.

Looking to the limited grievance of the petitioner is disposed of by directing the respondents/ competent authority to consider and decide the aforesaid representation of the petitioner dated 23.02.2025 (annexure P-6) in accordance with law and applicable transfer policy within a period of six weeks from today. The decision so arrived at shall also be communicated to the petitioner.


The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any.

And whereas upon passing of above directions, the representation has received on dated 07.04.2025 has been perused and examined and it has been observed that he has requested for his transfer either at GSSS Tauni Devi,(Hamirpur)/ GSSS Kakriar, (Hamirpur) against vacancy/ against the post being vacated due to promotion or longer stayee by clubbing policy of the state.

And whereas, at present there is no vacant posts of Lecturer Physics available at the station of his choice. However, Govt. Sr. Sec. School Somakothi, Distt. Mandi where the petitioner is posted at present is a soft area station and petitioner must serve at this station in the interest of students.

And whereas, as per para 12.1 of "Comprehensive Guiding Principles-2013" the transfer of the State Government employees, it is clearly mentioned that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/ transfer any employee anywhere in the state keeping in view of the administrative exigencies/ convenience.

And whereas, now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and rejected on the ground that petitioner is posted at soft area station and in the interest of students his services are urgently required in the present place of posting. Accordingly his representation stand disposed of.
