ORDER

In the matter of: CWP No. 49/2026 titled as Arvind Kumar, TGT (NM) Vs. State of H.P. & others.

Whereas, Sh. Arvind Kumar, TGT (NM) presently working in GMS Guwar u/c GSSS Guwan, Distt Chamba has filed CWP No. 49/2026 titled as Arvind Kumar, TGT (NM) Vs. State of H.P. & others. before the Hon'ble High Court, seeking the relief that he may transferred from GMS Guwar u/c GSSS Guwan, Distt. Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 02.01.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

“ Since it is apparent from the pleadings adduced on record by the petitioner that petitioner has already completed normal tenure of posting in hard/sub-cadre area i.e. two winter and three summers, coupled with the fact that transfer policy formulated by the Government of Himachal Pradesh enables an employee to seek transfer from hard /tribal area to soft area after his having completed normal tenure of posting in hard/tribal area, this Court sees no impediment in issuing direction to the respondents to consider and decide the representation dated 13.12.2025 (Annexure P-3) of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate order. It is further clarified that while passing necessary orders with regard to transfer of the petitioner, condition of substitute shall not be applied. Pending applications, if any, also stand disposed of.”

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.01.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Guwar u/c GSSS Guwan, Distt Chamba to GMS Kadar Mandir u/c GSSS Daroh or GMS Jangal u/c GSSS Alampur or GMS (G) Bhawarna u/c GSSS Bhawarna or GHS Bari u/c GSSS Bhawarna or GMS Badain u/c GSSS Boda or GMS Chentti u/c GSSS Balakrupi or GMS Dagera u/c GSSS Gharana Distt. Kangra against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Guwar u/c GSSS Guwan, Distt Chamba since 28.12.2022. GMS Guwar falls in hard area. The said teacher has completed his normal tenure in hard area i.e. two winters and three summers. One, Sh. Madan Lal, TGT (NM) has been working in GMS Chentti u/c GSSS Balakrupi, Distt. Kangra since 08.03.2021 and has completed his normal tenure of three years at present place of posting.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GMS Guwar u/c GSSS Guwan, Distt Chamba to GMS Chentti u/c GSSS Balakrupi, Distt. Kangra without TTA/JT vice Sh. Madan Lal, TGT (NM) and vice versa with TTA/JT.

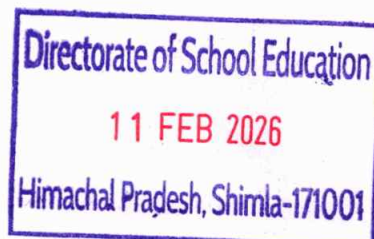
Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
