**ORDER**

In the matter of: CWP No. 8583/2025-titled as Bhupender Singh, TGT (Arts) V/s. State of Himachal Pradesh.


The petitioner has filed present CWP No. 8583/2024 titled as Bhupender Singh V/s State of H.P. in the Hon'ble High Court vide which sought his transfer from GSSS Badgran Distt. Chamba to a soft area or one of station of his choice as he has completed his normal tenure at present place of posting. The case was listed before the Hon'ble High Court of H.P. on 23.5.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

**"Consequently, in view of the above, this Court without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to decide the pending representation (Annexure P-1) expeditiously, preferably, within three weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon taking note of clauses 12, 15 and 16.1 of the transfer policy."**

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for personal hearing on 24.06.2025 and appeared before the undersigned on scheduled date. The petitioner has sought his transfer/adjustment either at GSSS Raja Ka Talab/Dhameta/Sidhpur Ghar/Manoh Sihal/GSSS Badiali Distt Kangra as he has completed his normal tenure at present place of posting i.e. Tribal area.

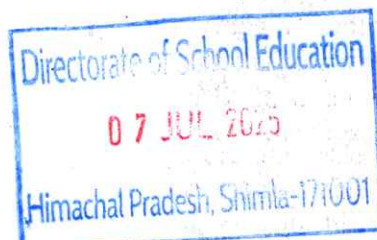
From the perusal of record, it is found that Sh. Bhupinder Singh, TGT (Arts) is working at GSSS Badgran (Tribal area) Distt. Chamba since 04.04.2022 and completed his normal tenure at present place of posting. At present post of TGT (Arts) are not lying vacant in ibid mentioned schools, however one Smt. Anu Radha, TGT (Arts) working at GSSS Dhameta Distt. Kangra who is working since 26.3.2021 and has completed her normal tenure at present place of posting.


Keeping in view the position stated above, representation of the petitioner i.e Sh. Bhupender Singh, TGT (Arts) is considered sympathetically and she is hereby adjusted from GSSS Badgran Distt. Chamba to GSSS Dhameta Distt. Kangra vice Smt. Anu Radha, TGT (Arts) who may further be transferred/adjusted at GSSS Badgran Distt. Chamba, (with TTA/JT to Smt. Anu Radha, TGT (Arts)). Therefore, representation of the petitioner with the present CWP is disposed of accordingly.
