ORDER

In the matter of:

CWP No. 17654/2025- Sh. Parveen Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Parveen Kumar, TGT(NM) presently working in PM SHRI GHS Sakori, Distt. Solan has filed CWP No.17654/2025 titled as Parveen Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from PM SHRI GHS Sakori, Distt. Solan to one of the stations of his choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 13.11.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner dated 31.07.2025 (Annexure P-1) in accordance with law and applicable transfer policy, within a period of four weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 09.12.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from PM SHRI GHS Sakori, Distt. Solan to GSSS Badhani or GSSSDarbiar or GHS Nagrota or GSSS Bhareri or GSSS Bedhar, Distt. Hamirpur or GSSS Bagra Galu or GSSS Chandesh, Distt. Mandi, against vacancy or longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working in PM SHRI GHS Sakori, Distt. Solan since 15.12.2021 on regular basis and has completed his normal tenure of three years. At present, one post of TGT(NM) is lying vacant at GSSS Chandesh, Distt. Mandi.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from PM SHRI GHS Sakori, Distt. Solan to GSSS Chandesh, Distt. Mandi, against vacancy without TTA/JT as per his request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
