Whereas, Smt. Seema Rana, TGT(NM) presently working in GHS Datyar u/c GMSSS Rajri Jabli, Distt. Solan has filed CWPNo.13239/2025- titled as Smt. Seema Rana Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be transferred from GHS Datyar u/c GMSSS Rajri Jabli, Distt. Solan to one of the stations of her choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 22.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"It is quite apparent from the pleadings adduced on record by the respective parties that petitioner is due to retire in the month of February, 2028, meaning thereby petitioner is left with more than two years, whereas transfer policy provides relaxation to employees left with less than two years of service. However, taking note of the fact that in another six months petitioner would be eligible to seek transfer on aforesaid ground, this Court without going into the merits of the case, deems it fit to dispose of the present petition, with a direction to the respondents to consider and decide the representation dated 29.06.2025 (Annexure P-1) within a period of eight weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note transfer policy. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 09.09.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GHS Datyar u/c GMSSS Rajri Jabli, Distt. Solan to GMS Sain Behal u/c GHS Kathalag or GSSS Sadyana or GSSS Gharan, Distt. Mandi, against vacancy.

After perusal of relevant record, it is revealed that the petitioner has been working in GHS Datyar u/c GMSSS Rajri Jabli Jabli, Distt. Solan since 13.03.2024 and has not completed her normal tenure of three years at her present place of posting. In the transfer policy at clause No. 10 it has been mentioned that the Government can transfer any officer/official at any time irrespective of stay, in view of administrative exigency, in the public interest. However, normally the tenure/stay of an officer/official at one station shall be three years which will not be applicable to the Officers of IAS/HPAS/HPPS/HPFS, other allied Services and all Class-1 & II Officers.

Therefore, keeping in view the clause mentioned in the transfer policy elaborated hereinabove in the above para, the request made by the petitioner on 09.09.2025 is not acceded to. The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
