and others.

Whereas, Piar Chand, TGT (NM) presently working in GMS Rajindu u/c GMSSS Saho, Distt. Chamba has filed CWP. No. 13881/2025- titled as Piar Chand, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Rajindu u/c GMSSS Saho, Distt. Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 28.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

**"6. Consequently, in view of the above, this Court finds merit in the present petition and accordingly, the same is allowed. Order dated 31.07.2025 is quashed and set aside with a direction to the respondents to consider and decide the representation of the petitioner afresh taking note of observations made hereinabove within two weeks from today. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy. Petitioner, while putting in appearance before authority concerned, may also point out any other station, where he can be given posting. Pending applications, if any, stand disposed of."**

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 25.09.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GHS Jammuhar u/c GSSS Luddu Distt. Chamba to GHS Tota Rani u/c GSSS Forsytganj or GMS Karahpura u/c GSSS Dhaloon or GMS Patti u/c GSSS Rajpur or GSSS Bir or GHS Sagoor u/c GSSS Rakkar Distt. Kangra against vacant post.


After perusal of the relevant record, it is revealed that the petitioner was transferred from GHS Jammuhar u/c GSSS Luddu, Distt. Chamba (Sub cader) to GMS Rajindu u/c GMSSS Saho, Distt. Chamba vide this office letter of even number dated 06.05.2025 with the prior approval of competent authority. As per information received in this office, the petitioner joined at the place of his posting in GMS Rajindu u/c GSSS Saho, Distt. Chamba on 10.07.2025. Sh. Piar Chand TGT (NM) has served Sub cader at GHS Jammuhar u/c GSSS Luddu, Distt. Chamba w.e.f. 11.12.2014 to 06.05.2025. At present, one post of TGT (NM) is lying vacant at GHS Sagoor u/c GSSS Rakkar Distt. Kangra.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GMS Rajindu u/c GSSS Saho, Distt. Chamba to GHS Sagoor u/c GSSS Rakkar Distt. Kangra against vacancy without TTA/JT as per his request.

The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
