ORDER

Sh. Tej Singh CHT has filed CWP No. 795/2026, titles as Tej Singh, CHT Vs State of HP, before the Hon'ble High Court for his transfer. The case was listed before the Hon'ble High Court on 08.01.2026, when the same was disposed of with following order:-

"True it is that petitioner has not completed normal tenure of posting at present place of posting, but once Transfer Policy, formulated by State of Himachal Pradesh, enables an employee to seek transfer on the ground of adverse family circumstances, this Court sees no impediment inasmuch as issuing direction to the respondents to consider and decide the pending representation (Annexure P-4) of the petitioner, expeditiously, preferably, within four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass speaking order taking note of transfer policy as well as observation made herein above. Pending application(s), if any, also stands disposed of."

In compliance of the above direction of the Hon'ble High Court, the petitioner appeared in person on 09.02.2026 and submitted his representation for his transfer. On the perusal of comments submitted by the DDSE(Ele.) Chamba, it is revealed that the petitioner Sh. Tej Singh, CHT has been working at GCPS Sanwal, E/B Tissa, Distt. Chamba, situated in hard area, since 13.09.2023. The petitioner has requested for his transfer to one of the vacant stations of his choice i.e. GCPS Chilli, E/B Kalhel, Distt. Chamba, HP.


In view of above facts, the representation of the petitioner has been examined after due consideration. Therefore, the/ Deputy Director of School (Ele.) Education, Chamba is hereby directed that the petitioner Sh. Tej Singh, CHT, may be transferred from GCPS Sanwal, E/B Tissa to GCPS Chilli, E/B Kalhel, Distt. Chamba, H.P., as per his own request against vacant post of CHT likely to be caused due to retirement of Sh. Shukar Deen CHT on 31.03.2026. The representation of the petitioner stand decided and disposed of accordingly.
