Disbursement of admissible amount to all Girls, ST, SC & BPL Boys of classes 1st to 8th for school uniform as per Government of India guidelines for the year 2025-26-reg.

Sir/Madam,

It is stated that on the basis of demand received from you, the requisite amount @ Rs. 600/- per student for Direct Benefit Transfer (DBT) to all Girls, ST, SC & BPL Boys of classes 1st to 8th for school uniform (PM SHRI Schools and Except PM SHRI Schools) as per Government of India guidelines for the year 2025-26 has been transferred by this office dated 27-02-2026, to your office Bank Accounts. In this context, following guidelines/instructions are being issued for disbursement of requisite amount to the eligible students through Direct Benefit Transfer (DBT) for the year 2025-26 as under:-

1. As per Government of India guidelines, an amount of Rs. 600/- per student be transferred through DBT for free school uniform to all Girls, ST, SC & BPL Boys of classes 1st to 8th for the year 2025-26. It has also been decided that the admissible amount be transferred through Direct Benefit Transfer (DBT) in the Bank Accounts of eligible students or his/her mother's Accounts.
2. A special drive be carried for opening the Bank Account of all students of classes 1st to 8th, so that the admissible amount for school uniform could be transferred to the eligible students through Direct Benefit Transfer(DBT) in their Bank Accounts or his/her mother's Account.
3. The funds should be transferred to the eligible beneficiary students within the period of **One Month** from the date of release of funds from the State level **and after then send the utilization certificate of utilized amount to this office within one week.**
4. No students from the above said categories should be left without Direct Benefit Transfer (DBT) of requisite funds amounting to Rs. 600/- for school uniform to the eligible students.
5. The interest accrued in the funds in the Bank of Baroda Accounts should be deposited in the relevant Head of Account in the Government Treasury.
6. You are further requested to furnish the undertaking to this office that all eligible students of above said categories have been given requisite funds amounting to Rs. 600/- through Direct Benefit Transfer(DBT) for school uniform i.e. all Girls, SC, ST & BPL Boys of classes 1st to 8th and no students have left without the abovesaid benefit in your District.
