ORDER

In the matter of:

CWP No. 13801/2025-titled as Monika Dhiman (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Smt. Monika Dhiman, TGT (Med.) has filed CWP No. 13801/2025 titled as Monika Dhiman V/s. State of H.P. in the Hon'ble High Court, and seeking her transfer from GSSS, Aerla Distt. (Kgr.) to GSSS, Hatwas District Kangra/ GHS Nanan Distt. (Kgr.) GSSS, Thural Distt. (Kgr.) against vacancy. The case was listed before the Hon'ble High Court of H.P. on 27.08.2025 on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Since it is quite apparent from the pleadings adduced on record that petitioner has already completed normal tenure at present place of posting coupled with the fact that she has suffered serious injuries in the accident and transfer Policy enables and employee to seek transfer on medical grounds, this Court sees no impediment in issuing direction to the respondents to consider and decided the representation of the petitioner expeditiously, preferably within three weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders. Pending applications, if any, stand disposed of."

As per the directions of the Hon'ble High Court, the petitioner was scheduled for a personal hearing on 15.09.2025. However, due to a serious accident, the petitioner was unable to attend the hearing. The petitioner has represented that she sustained a severe injury to her right foot, which has resulted in poor blood circulation as diagnosed by her treating doctor. She has undergone an additional surgery, and currently, a VAC (Vacuum-Assisted Closure) machine is being used on her foot. Consequently, she is bedridden and physically incapable of attending the personal hearing. In light of her medical condition, the petitioner requests that her case be considered for adjustment at one of the following vacancies:- GSSS, Hatwas Distt. (Kgr.), GHS, Nanan Distt. (Kgr.), GSSS, Thural Distt. (Kangra.)

From the perusal of record, it is found that Smt. Monika Dhiman, TGT (Med.) is working in GSSS, Aerla Distt. (Kgr.) since 22.03.2021 and has completed normal tenure at her present place of posting. At present one post of TGT (Med.) is lying vacant at GHS, Nanan Distt. (Kangra).

Keeping in view the position stated above, representation of the petitioner i.e Smt. Monika Dhiman, TGT (Med.) is considered sympathetically and hereby transferred from GSSS, Aerla Distt. (Kgr.) to GHS, Nanan Distt. (Kgr.) against vacancy, without TTA/JT on her own request. The representation of the petitioner is disposed of accordingly.
