**ORDER**

In the matter of: CWP No. 1015/2026- Sh. Rajesh Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Rajesh Kumar, TGT(NM) presently working in GSSS Ghain, Distt. Mandi has filed CWP No. 1015/2026 titled as Sh. Rajesh Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Ghain, Distt. Mandi to one of the stations of his choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 09.01.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

*"True it is that it is the sole prerogative of the employer to post an employee at a particular station, but once transfer policy formulated by the Government of Himachal Pradesh provides for minimum tenure of three years at one station, coupled with the fact that transfer policy formulated by the Government of Himachal Pradesh enables an employee to seek transfer on the ground of couple case, this Court, without going into the merits of the case, deems it fit to dispose of the same, with a direction to the respondents to consider and decide the pending representation (Annexure 1) of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate order, taking note of the fact that wife of the petitioner is also working as JBT and at present is posted at Government Primary School, Bagra, Education Block Sundernagar-II, District Mandi, Himachal Pradesh. Pending applications, if any, also stand disposed of."*

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 20.02.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Ghain, Distt. Mandi to GMS Kafangoon u/c GSSS Kataula, Distt. Mandi or GMS Dwahan u/c GSSS Kot Tungal or GSSS Drang or GSSS Ghasnoo, Distt. Mandi, against vacancy or longer stayee.

After perusal of relevant record, it is revealed that the petitioner has been working in GSSS Ghain, Distt. Mandi since 13.09.2022 and has completed his normal tenure of three years. At present, one post of TGT(NM) is lying vacant at GMS Kafangoon u/c GSSS Kataula, Distt. Mandi.

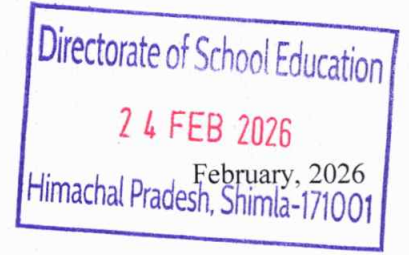
Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GSSS Ghain, Distt. Mandi to GMS Kafangoon u/c GSSS Kataula, Distt. Mandi, against vacancy, without TTA/JT on his own request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
