ORDER

Whereas the the petitioner Sh. Ravinder Singh DPE/Lect. Phy. Education was transferred from GSSS Samej (Kullu) (Hard Area) to GSSS Tharola (Shimla) against vacancy on dated 27.01.2026 in order to settle the CWP No.18618/2025, but he has challenged the said orders before the Hon'ble High Court under CWP No.1574/2026. This petition was listed before Hon'ble High Court on dated 02.02.2026 when the same was finally disposed with the directions to respondents as under:-

"Keeping in view the mandate of law of this Court referred hereinabove, the impugned order dated 27.01.2026 passed by respondent No.2 is quashed and set aside and the petitioner is directed to make a fresh representation within a week, mentioning therein five stations of his choice, out of which, one will be from other District and in case such representation is received by the respondent No.2/Competent Authority, the same shall be considered and decided within two weeks thereafter.


And whereas, to settle the said court case petitioner was called for personal hearing on 19.02.2026 for seeking his options. During the course of hearing petitioner has requested that due to his adverse family circumstance he is unable to join at GSSS Tharola (SML) as well as this station is far away from his native place and further requested that keeping in view of his grievances he may kindly be transfer from GSSS Samej (Kullu) to one of the station of his choice i.e. GSSS Masli (Shimla), Dhamwari (Shimla)/Saribasa (Shimla)/Gaonsari (Shimla), GSSS (B) Solan (Solan) against longer stay.

Now therefore, after taking into account of the above facts and circumstances of the case, it is examined and found that at present Sh. Ravinder Kumar, DPE/Lect. Phy.Education is completing his stay at GSSS Saribasa (SML) and request of petitioner is being considered against him. Hence, Sh. Ravinder Singh, DPE/Lect. Phy. Education (petitioner) is being transferred from GSSS Samej (Kullu) to GSSS Saribasa (Shimla) vice Sh. Ravinder Kumar DPE/Lect. Phy. Education, who is being further transferred to GSSS Tharola (Shimla) against vacancy with TTA/JT.

With these observations, representation stands disposed of.
