and others.

Whereas, Tanu Kumari, TGT (NM) previously working in GSSS Passu, Distt. Kangra has filed CWP. No. 13464/2025- titled as Tanu Kumari, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that she may be adjusted at one of the stations of her choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 22.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Notice in the aforesaid terms. Since, the petitioner has already been relieved, it is ordered that she will not be compelled to join the station to which she has been transferred till the next date of hearing. It is also the contention of the petitioner that she has already made representation to the competent authority for her adjustment at a suitable place keeping in view her compelling family circumstances. Respondent No.2 will consider the representation of the petitioner expeditiously."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 25.08.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be adjusted at GSSS Dari or GSSS Mandal or GMS Chandmari u/c GSSS Forsythganj or GMS lohna u/c GSSS Palampur or GMS Patti u/c PM SHRI GMSSS Rajpur or GHS Menja or GSSS (G) Nagrota Bagwan against longer stayee or against vacancy.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GSSS Passu, Distt. Kangra to GMS Lohani u/c GSSS Salooni, Distt. Chamba in view of CWP No. 12866/2925 titled as Rivender Kumar Vs. State of H.P.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby adjusted at GSSS Mandal, Distt. Kangra against vacancy without TTA/JT.
