ORDER

In the matter of: CWP No. 4337/2025-titled as Dipti Thakur, TGT (Arts) V/s. State of Himachal Pradesh.

The petitioner has filed present CWP No. 4337/2025 titled as Dipti Thakur V/s State of H.P. in the Hon'ble High Court vide which seeking her transfer. The case was listed before the Hon'ble High Court of H.P. on 25.3.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

“..direction to the competent authority to consider and decide pending representation of the petitioner expeditiously, preferably, within three weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful shall afford an opportunity of hearing to the petitioner and pass appropriate order taking note of the transfer policy, which admittedly provides for transfer of an employee after completion of normal minimum period at one place and transfer to some other place of choice. Pending applications also stand disposed of.”

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner Smt. Dipti Thakur, TGT (Arts) has attended the personal hearing on 26.4.2025 and has submitted representation, wherein request to transfer either to GSSS Nabahi (MND)/GSSS Bhambla (MND)/GSSS Kolni Dhalwan (MND)/GSSS Baldwara (MND)/GSSS Bhareri (HMR)/GSSS Khanot (MND)/GHS Kehri u/c GSSS Baldwara (MND)/GSSS Jaku (HMR), against vacancy/longer stayee by clubbing their previous posting tenure.

From the perusal of record, it is found that Smt. Dipti Thakur, TGT (Arts) is working at GHS Shawala u/c GSSS Nerwa Distt. Shimla since 23.2.2022 and has completed her normal tenure. At present post of TGT (Arts) are not lying vacant in ibid mentioned schools, however one Smt. Aruna Kumari, TGT (Arts) is working at GSSS Kolni Dhalwan Distt. Mandi since 08.09.2022 and having short stay, but serving within the radius of 30 kilometers since 2016.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Dipti Thakur, TGT (Arts) is considered sympathetically and petitioner is hereby transferred from GHS Shawala u/c GSSS Nerwa Distt. Shimla to GSSS Kolni Dhalwan Distt. Mandi vice Smt. Aruna Kumari, TGT (Arts) and vice versa by clubbing her previous place of postings tenure (with TTA/JT to Smt. Aruna Kumari). Therefore, representation of the petitioner with the present CWP is disposed of accordingly.
