Whereas, Sh. Ravi Chander, TGT (NM) preferred CWP No. 4125/2025 titled as Ravi Chander Vs State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Dhar u/c GSSS Jadera, Distt. Chamba to the station nearby his native place in Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 22.03.2025 when the Hon'ble High Court has passed the following orders:-

"5. Consequently, in view of the above, this Court without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation of the petitioner expeditiously, Preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while affording opportunity of hearing to the petitioner, shall also take note of the transfer policy formulated by the Government of Himachal Pradesh, which provides for transfer of are employee from hard/rural area to soft area after his/her having completed normal tenure at present place of posting and pass appropriate orders. Pending applications, if any, also stand disposed of."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 25.04.2025. He has attended the same and submitted his representation in this office on 25.04.2025 vide which he has requested that he has completed normal tenure at his present place of posting i.e GHS Dhar u/c GSSS Jadera, Distt. Chamba and he further requested that he may be transferred/adjusted in Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay.

From perusal of record, it has been found that the petitioner is working at GHS Dhar u/c GSSS Jadera, Distt. Chamba, w.e.f. 25.11.2021 wherein the enrollment of students is 46(Aprx.). At present post of TGT (NM) are not lying vacant in the above mentioned school.

As per provision contained in comprehensive guidelines Principles -2013 for regulating the transfer of State Government employees, it is specifically mentioned in para 12.1 "All employees during their period of service will serve for at least single tenure in tribal/difficult/Hard area and remote/rural areas. Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the State, keeping in view of the administrative exigencies/convenience." Therefore, being a State cadre Government employee, the request of the petitioner is not tenable and hereby rejected.
