ORDER

In the matter of:

CWP No. 16333/2025- titled as Jatinder Vs. State of H.P. and

others.

Whereas, Jatinder, TGT (NM) presently working in GMS Rulang u/c GSSS Barot Distt. Mandi has filed CWP. No. 16333/2025- titled as Jatinder, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Rulang u/c GSSS Barot, Distt. Mandi to one of the stations of his choice in Distt. Mandi/Kangra. The case of the petitioner was listed before the Hon'ble High Court on 16.10.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Consequently, in view of the above, the present petition is disposed of with a direction to the respondents to consider and decide the representation (Annexure P-5), of the petitioner expeditiously, preferably within a period of four weeks, taking note of transfer policy formulated by the Government of Himachal Pradesh, which enables an employee to seek transfer from hard area to soft area after his/her having completed normal tenure of posting. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 14.11.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Rulang u/c GSSS Barot Distt. Mandi to GMS Badsar u/c GSSS Jia or GHS Panthehar u/c GSSS Rajpur or GSSS Nimeraly Distt. Kangra/Mandi against longer stayee or against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Rulang u/c GSSS Barot Distt. Mandi (Hard area) since 20.09.2024. At present, one post of TGT (NM) is lying vacant at GSSS Nimeraly, Distt. Mandi.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GMS Rulang u/c GSSS Barot Distt. Mandi to GSSS Nimeraly, Distt. Mandi against vacancy without TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
