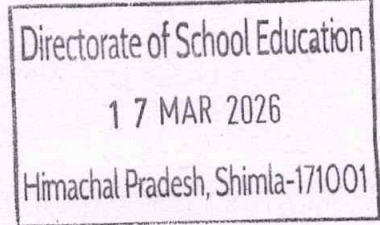

**ORDER**

Whereas, Smt. Arti Lect./Lect.(SN) Commerce has filed CWP No. 2366/2026 before the Hon'ble High Court regarding seeking his transfer from GSSS Barot (Mandi) (hard area) to one of the station of her choice i.e. GSSS Urla/ GSSS Padhar GSSS Darang/GSSS Gumma/GSSS Katindhi Distt. Mandi against longer stayee, as she has completed her normal tenure in hard area.

The case was listed before the Hon'ble Court on 02.03.2026 when the case was disposed of with the following directions:-

**“Without making any observations on the merits of the case, this petition is disposed of with the direction that the representation filed by the petitioner be decided by the competent authority within a period of eight weeks from today. Pending miscellaneous applications, if any, also stand disposed of.”**

**And whereas,** in compliance of Hon'ble High Court direction petitioner was called for personal hearing on 16.03.2026. During the course of hearing petitioner has informed that she is posted in hard area since December 2021, and completed her normal tenure in hard area. Due to her adverse family circumstances she may kindly be adjusted at GSSS Urla/ GSSS Padhar/GSSS Darang/GSSS Gumma/ GSSS Katindhi Distt.Mandi against longer stayee.

**And whereas,** while examining her representation it is found that at present Smt. Anita Thakur Lect./Lect. (SN)Commerce is working at GSSS Urla (Mandi) w.e.f. 24.12.2021 & has completed her normal tenure.

**Now therefore,** after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically and petitioner i.e. Smt. Arti Lect./Lect.(SN) Commerce , who is posted at GSSS Barot (Mandi) is hereby transferred to GSSS Urla (Mandi) without TTA/JT vice Anita Thakur Lect./Lect.(SN) Commerce and vice versa, with TTA/ JT.

With these observations, representation stands disposed of.

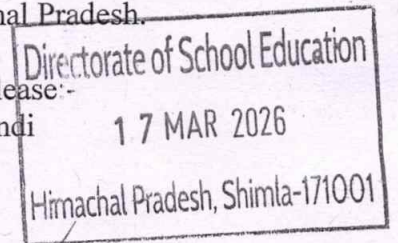
