ORDER.

In the matter : CWP No. 13939/2025 titled as Sonika Chandel, TGT(Med) VS State of H.P. & others.

The Petitioner Smt. Sonika Chandel, TGT(Med)) filed CWP No. 13939/2025 titled as, Sh. Sonika Chandel, TGT(Med) Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS, Bakras Distt. (Smr.) to GSSS, Dehlan Distt. (Una). The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 29.08.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Consequently, in view of the aboe, the present petition is disposed of, with a direction to the respondents to consider and decided of, with a direction to the respondents to consider and decided the representation dated 24.10.2024 (Annexure P-4) of the petitioner expeditiously, preferably within a period of three weeks. Needless to say, authority concerned, while doing the needful in terms of instant order, taking note transfer policy. Pending applications, if any, a so stand disposed of."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 17.10.2025. The petitioner attended the personal hearing on scheduled date and time. During personal hearing she has requested to adjust her at GSSS, Dehlan Distt. Una against vacancy.

From perusal of the record, it is observed that Smt. Sonika Chandel, TGT (Medical) was appointment on contract basis on 19.07.2024 and has been serving at GSSS, Bakras Distt. (Smr.). She has not yet completed the normal tenure at her present place of posting, which falls in the Sub cadre area.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
