OFFICE ORDER

In the matter of: CWP No. 2533/2026-titled as Ravi Kumar, Vs. State of H.P &Others.

Whereas, Sh. Ravi Kumar, Lect. Math preferred CWP No. 2533/2026 titled as Ravi Kumar, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Matour, Distt. Kangra to GSSS Chandpur, Distt. Bilaspur, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 05-03-2026 when the Hon'ble High Court has passed the following orders:-

3. " *In light of the fact that the petitioner has already completed more than five years at GSSS Matour, the Court is not interfering with the impugned transfer order, that is to say that it is not interfering with the transfer of the private respondent in place of the petitioner to GSSS Matour but this petition is disposed of with the direction that the petitioner shall be at liberty to file a representation for his adjustment within a week from today. This representation shall be decided by the Authority within two weeks as from the date of receipt thereof by taking into consideration the factum of superannuation of the petitioner. Till the representation is decided, the petitioner can avail the kind of leave due to him and he shall not be forced to join the station to which he stands transferred. Pending miscellaneous application(s), if any, also stand disposed accordingly.*"

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 24-03-2026. He attended the same and submitted his representation in this office, vide which he has requested that he is on verge of retirement on 31-01-2028 and he may be adjusted at GMSSS Sehwan, Distt. Kangra, against vacancy being caused due to promotion of present incumbent as Principal.

In the perusal of the record, it is found that the petitioner is working at GSSS Matour, Distt. Kangra and under transfer to GSSS Chandpur, Distt. Bilaspur, H.P. The petitioner is going to be retire on 31-01-2028. One post of Lect. Math is going to be vacant after 31-03-2026 at GMSSS Sehwan, Distt. Kangra, H.P due to promotion of present incumbent as principal. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby adjusted at GMSSS Sehwan, Distt. Kangra, H.P, against vacancy after 31-03-2026 being caised due to Promotion of present incumbent. These orders will be implemented after 31-03-2026. The representation of the petitioner is disposed of accordingly.
