**ORDER**

In the matter of: CWP No. 1848/2026- Sh. Seema Rana, TGT(NM) Vs. State of H.P. and others.

Whereas, Smt. Seema Rana, TGT(NM) presently working in GHS Datar u/c GMSSS Rajri Jabli, Distt. Solan has filed CWPNo.1848/2026 titled as Smt. Seema Rana Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be transferred from GHS Datar u/c GMSSS Rajri Jabli, Distt. Solan to one of the stations of his choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 13.02.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

*"Accordingly, this petition is disposed of with a direction to the respondents/authority to decide the representation of the petitioner dated 09.01.2026 (Annexure P-3) sympathetically within a period of two weeks' from today by passing a speaking order and after giving an opportunity of being heard to the petitioner and the same shall be communicated to the petitioner.*

*It is made clear that this Court has not expressed anything on the merits of the case, and the authority shall take a decision strictly in consonance with the provisions of law.*

*Petition stands disposed of, so also the pending application(s), if any ."*

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 20.02.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GHS Datar u/c GMSSS Rajri Jabli, Distt. Solan to GMSSS Drang, Distt. Mandi, against vacancy.

After perusal of relevant record, it is revealed that the petitioner has been working in GHS Datar u/c GMSSS Rajri Jabli, Distt. Solan since 13.03.2024. At present, one post of TGT(NM) is lying vacant at GMSSS Drang, Distt. Mandi.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby transferred from GHS Datar u/c GMSSS Rajri Jabli, Distt. Solan to GMSSS Drang, Distt. Mandi, against vacancy, without TTA/JT, as per her request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
