Whereas, Smt. Shri Devi, TGT (NM) preferred CWP No. 111/2025 titled as Smt. Shri Devi, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding her transfer from GSSS Madgram, Distt. Lahoul & Spiti, H.P to nearby Distt. Kullu, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 03-01-2025, when the Hon'ble High Court has passed the following orders:-

*"3. As prayed for, this petition is disposed of with liberty to the petitioner to move an appropriate representation to the Authority concerned, redressing therein the issue raised in the petition . In the event of any such representation being filed by the petitioner within a period of two weeks from today, the same be decided by the competent authority in terms of the averments contained therein within a period of eight weeks from the date of receipt thereof. Pending miscellaneous application(s), if any also stand disposed of."*

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner has submitted her representation in this office on dated 08-10-2025, vide which She has requested that She may be transferred from GSSS Madgram, Distt. Lahoul & Spiti, H.P to GSSS Bajaura, Distt. Kullu, H.P, against vacancy .

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Madgram, Distt. Lahoul & Spiti, H.P, since, **02-05-2018** which is a tribal area and has completed the Six years tenure at present place of posting. At present the post of TGT (NM) is lying vacant at GSSS Bajaura, Distt. Kullu, H.P. and (429) students are studying in this school. The petitioner has given willingness for her transfer to the aforesaid school against vacancy. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and She is hereby transferred from GSSS Madgram, Distt. Lahoul & Spiti, H.P to GSSS Bajaura, Distt. Kullu, H.P., against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
