## ORDER

In the matter of:

CWP No. 13720/2025-titled as Bhupender Kumar (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Sh. Bhupender Kumar, TGT (Med.) has filed CWP No. 13720/2025 titled as Bhupender Kumar V/s. State of H.P. in the Hon'ble High Court, and seeking his transfer from GHS, Kalhani u/c GSSS, Sarachi Distt. (Mandi) to District Mandi against vacancy. The case was listed before the Hon'ble High Court of H.P. on 26.08.2025 on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Accordingly, the petition is disposed of with direction to respondent No.2 to consider and decide the representation of the petitioner (Annexure P-2 within a period of three weeks from today, strictly in terms of the transfer policy of the State Government. Pending applications, if any, also stand disposed of."

As per the directions of the Hon'ble High Court, the petitioner was called for a personal hearing, which he attended on 22.09.2025. During the hearing, he stated that he has been suffering from Critical Congenital Heart Disease, specifically Tricuspid Atresia, since childhood. He further explained that due to the absence of proper road facilities, he has to walk 4 kilometers to reach his school. In view of these circumstances, he has requested to be accommodated against a vacancy at GSSS, Dasehra, District Mandi.

From the perusal of record, it is found that Sh. Bhpender Kumar, TGT (Med.) is working at GHS Kalhani u/c GSSS, Sarachi Distt. (Mandi) since 11.08.2022 and has completed normal tenure at her present place of posting. At present one post of TGT (Med.) is lying vacant at GSSS, Dasehra Distt. (Mandi).

Keeping in view the position stated above, representation of the petitioner i.e Sh. Bhupender Kumar, TGT (Med.) is considered sympathetically and hereby transferred from GHS Kalhani u/c GSSS, Sarachi Distt. (Mandi) to GSSS, Dasehra Distt. (Mandi) against vacancy, without TTA/JT on his own request. The representation of the petitioner is disposed of accordingly.
