In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 11.08.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GMS Kedara u/c GSSS Daroh, Distt. Kangra against longer stayee.

Vineet Kumar Korla, TGT (NM) has been working in GMS Kedar Mandir u/c GSSS Daroh, Distt. Kangra since 29.11.2021 and has completed his normal tenure of three years at present place of posting.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted at GMS Kedar Mandir u/c GSSS Daroh, Distt. Kangra without TTA/JT vice Vineet Kumar Korla, TGT (NM) and Sh. Vineet kumar Korla TGT (NM) is hereby further transferred to GMS Madhana u/c GSSS Tharoch (Nerwa), Distt. Shimla against vacancy with TTA/JT.
