**ORDER**

The petitioner has filed CWP No. 17427/2025 titled as Inder Singh, TGT(Hindi), Vs state of HP & others. Regarding his transfer from GSSS Bairagarh (Tissa) District Chamba (which falls under hard area). The case was listed before the Hon'ble High Court of H.P. on 11.11.2025. The Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

*" Since it is quite apparent from the pleadings adduced on record by the petitioner, which are duly supported by the affidavit that prior to petitioner's transfer to Government Senior Secondary School, Bairagarh vide impugned transfer order dated 4.4.2025, he was working as Language Teacher at Government Senior Secondary School Bharmour for more than 20 years, coupled with the fact that transfer policy formulated by the Government of Himachal Pradesh enables an employee to seek transfer from hard area to soft area after his/her having completed normal tenure of posting i.e. two winters and three summers, there appears to be no impediment in issuing direction to the respondents to consider and decide the pending representation (Annexure P-2) of the petitioner for his transfer from Government Senior Secondary School, Bairagarh to one of the stations as detailed in the representation expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate order, taking note of the fact that petitioner has already worked in hard area for more than 20 years, if it is so, he is otherwise entitled to be given posting of his choice. Pending application(s), if any, also stands disposed of."*

In compliance to the order passed by of the Hon'ble High Court, the petitioner was called for personal hearing on dated 15<sup>th</sup> Dec.2025 and he attended the same. At the time of hearing petitioner has requested that he may be transferred from GSSS Bairagarh (Tissa) (which falls under /Tribal area) District Chamba to GGSSS Bharmour/GSSS Hatli/GSSS Thulel /GSSS Chowari(CBA) District Chamba against vacancy /longer stayee. He has further stated that he has old ailing parents and there is no one in the family to look after him.

From the perusal record, it reveals that the petitioner i.e. Sh. Inder Singh, TGT (Hindi) is presently working in GSSS Bairagarh(Tissa), District Chamba since 09.04.2025. The petitioner have already been rendered around 20 to 21 years of service in hard/sub cadre area. In view of adverse circumstances of the petitioner the representation of the petitioner is hereby considered sympathetically and he is hereby transferred from GSSS Bairagarh(Tissa) District Chamba to GGSSS Bharmour(CBA) against vacancy without TTA/JT. Keeping in view the position stated above, representation of the petitioner is considered and disposed of accordingly.
