**ORDER** 

In the matter of:

CWP No. 11901/2025-titled as Anita, TGT (Med.) V/s. State of Himachal Pradesh and others (Regarding Transfer).

The Petitioner Anita,TGT(Med)) filed CWP No. 11901/2025 titled as, Anita,TGT(Med) Vs. State of H.P. before the Hon'ble High Court of H.P. seeking her transfer from GMSSS, Dand Distt. Chamba to Distt. (Kangra) against longer stay by clubbing the previous stay or GSSS kandbari Distt. Kangra against vacancy due to promotion. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 24.07.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"In view of the above, this Court finds merit in the present petition and accordingly, the same is allowed. Impugned order dated 18.07.2025 (Annexure P-5) is quashed and set aside. Respondents are directed to consider and decide the representation dated 20.05.2025 (Annexure P-4) afresh taking note of adverse family circumstances, as detailed in the representation. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders. Pending applications, if any, stand disposed of."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Anita. TGT (Med.) was called for personal hearing on 11.08.2025 during the hearing, she submitted that she is the elder daughter in her family and, following the demise of her father, there is no one else available to take care of her ailing mother. In light of these compassionate grounds, she has requested to be adjusted in District Kangra either against a vacancy or by considering her against a longer stayee.

From the perusal of record, it is found that Smt. Anita, TGT (Med.) was working in GMSSS, Dand Distt. (Chamba) since 22.02.2022 and has completed normal tenure at her present place of posting. Moreover, GSSS, Kandbari Distt. Kangra is going to be vacant due to promotion.

Keeping in view the position stated above, representation of petitioner is considered sympathetically and Anita, TGT (Med.) is hereby transferred from GMSSS, Dand Distt. Chamba to GSSS, Kandbari Distt. Kangra against vacancy, caused due to promotion. Accordingly, the representation of the petitioner, Anita, TGT (Med.), is disposed of with these observations.
