## ORDER

Whereas, the petitioner namely Sh.Attar Singh Lect.(Hindi) is working at GSSS Jarwa Juneli (Smr) w.e.f 09.01.2015 and completed his normal stay and the school fall in sub-cader area. He has filed CWP No. 13899/2025 titled as Attar Singh vs State of HP. This petition was listed on 29.08.2025 when the same was finally disposed with the directions to respondents as under:-

"Since it is quite apparent from the pleadings adduced on record that petitioner has been working in hard area for more than 19 years, coupled with the fact that Transfer Policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer from hard area to soft area on his/her having completednormal tenure i.e. two winters and three summers, this Court sees no impediment in issuing directions to the respondents to consider and decide the pending representation of the petitioner (Annexure P-1) expeditiously, preferably within four weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of observations made herein above as well as Transfer Policy formulated by the Government of Himachal Pradesh. Pending applications, if any, stand disposed of"

And whereas, in compliance of Hon'ble High Court order dated 29.08.2025, the petitioner was called for personal hearing on 14.10.2025. During the course of hearing petitioner has requested that he may be adjusted at GSSS Jamta (Smr) against vacancy due to retirement on 31.03.2026.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a representation of petitioner has been considered and allowed. The petitioner i.e Sh.Attar Singh Lect.(Hindi) is being transfer from GSSS Jarwa Juneli (Smr) to GSSS Jarma (Smr) against vacancy due to retirement on 31.03.2026 as per his request with the condation that these orders shall come into force on or after 01.04.2026. Hence representation stands disposed of.
