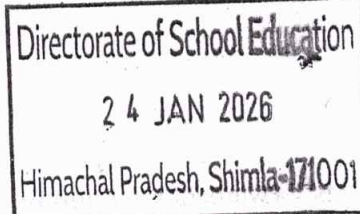

ORDER

Whereas, Sh. Tilak Raj, DPE/Lect. Physical Education presently posted at GSSS Samour (MND) w.e.f. 05.05.2025 has filed CWP No. 17287/2025 before the Hon'ble High Court regarding to direct the respondent to decide his pending representation wherein he has seeking his transfer from GSSS Samour (Mandi) to his choice of station i.e. GSSS Harabag (Mandi) against vacancy and GSSS Sainthal(MND) or GSSS (B) Jogindernagar (Mandi) against longer stayee, on medical grounds and being a couple case.

The case was listed before the Hon'ble Court on 20.11.2025 when the case was disposed of with the following directions:-

“Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide the pending representation of the petitioner expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders there upon taking note of the fact that wife of the petitioner is also Government employee and at present, she is working as TGT (Arts) at GSSS Sakari, Tehsil Baijnath, District Mandi. Pending application(s), if any, also stands disposed of.”

And whereas, to settle the said court case petitioner was called for personal hearing on 16.01.2026. During the course of hearing petitioner has requested that he is suffering from a severe cardiac ailment and is undergoing treatment from Dr. RP Govt. Medical College & Hospital Kangra at Tanda. His current place of posting is far away from his home and the specialized medical facilities necessary for his treatment and further requested that he may kindly be transferred to his choice of station being a couple case as his wife is also working as TGT at GSSS Sakari Distt. Kangra.


And whereas, that the matter has been examined and found it is not feasible to transfer Sh. Tilak Raj, DPE from GSSS Samour (MND) to his choice of station due to his very very short stay i.e. 05.05.2025 as well as he is posted in soft area. However, and as per “Comprehensive Guiding Principles- 2013” for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience.

Now therefore, after taking into the account of above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected.

With these observations, representation stands disposed of.
