ORDER.

In the matter : CWP No. 20420/2025 titled as Vinod Kumar, TGT(Med) VS State of H.P. others.

The Petitioner Sh. Vinod Kumar, TGT(Med)) filed CWP No. 20420/2025 titled as, Sh. Vinod Kumar, TGT(Med) Vs. State of H.P. before the Hon'ble High Court of H.P. and seeking his transfer from GHS, Amboi U/c GMSSS, Jangla District Shimla to District Mandi. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 23.12.2025 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

*"Having regard to the afore-submission, but without examining the merits of the matter, this writ petition is disposed of with direction to respondent No. 2/ competent authority to consider and decide the aforesaid representation of the petitioner dated 08.12.2025 (Annexure P-1) in accordance with law and applicable transfer policy within a period of two weeks from today. The decision so arrived at shall also be communicated to the petitioner."*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 19.02.2026. The petitioner attended the personal hearing scheduled date and time and has requested to adjust him at District Mandi.

From the perusal of the record, it reveals that Sh. Vinod Kumar, TGT (Med.) is working in GHS, Amboi U/c GMSSS, Jangla District Shimla since 21.02.2022 and has completed his normal tenure at present place of posting. Moreover, GHS, Amboi U/c GMSSS, Jangla District Shimla falls in soft area. As per Annexure-1, he has requested adjustment in District Mandi and has suggested certain stations against his longer stay; however, he did not given any vacant position where he can be posted.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
