**ORDER**

In the matter of: CWP No. 10503/2024-titled as Minakshi, TGT (Arts) V/s. State of Himachal Pradesh.

The petitioner has filed present CWP No. 10503/2024 titled as Minakshi V/s State of H.P. in the Hon'ble High Court vide which seeking her transfer from GSSS Thaltukhod, Distt. Mandi either to GMS Kamehar/GSSS Bassi/GSSS Makreri/GHS Seru/GSSS Boys Joginder Nagar Distt. Mandi or GSSS Bir, Distt. Kangra against vacancy/longer stayee/clubbing the stay of incumbents. The case was listed before the Hon'ble High Court of H.P. on 20-09-2024, on this day Hon'ble Court has passed order/judgment.

In compliance to the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the case of the petitioner examined and it is found that Smt. Minakshi, TGT (Arts) is working at GSSS Thaltukhod (Sub Cadre area), Distt. Mandi since 14.11.2019 and has completed her normal tenure at present place of posting. At present post of TGT (Arts) is not lying vacant in ibid mentioned schools, however one Smt. Ritu Guleria, TGT (Arts) is working at GSSS Bir, Distt. Kangra since 21.09.2021 and completed her normal tenure at present place of posting.

Keeping in view the position stated above, the petitioner Smt. Minakshi, TGT (Arts) is hereby transferred from GSSS Thaltukhod, Distt. Mandi to GSSS Bir, Distt. Kangra vice Smt. Ritu Guleria, TGT (Arts) being longer stayee (with TTA/JT to Smt. Ritu Guleria, TGT (Arts)). Therefore, case of the petitioner is disposed of accordingly.

**ORDER**

In the matter of: CWP No. 855/2025-titled as Smt. Sanjay Bala (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Smt. Sanjay Bala, TGT (Med.) has filed CWP No. 855/2025 titled as Sanjay Bala V/s. State of H.P. in the Hon'ble High Court, and seeking her transfer from GHS, Jammuhar, U/c Ludoo Distt. Chamba to GSSS, Kaned, GSSS, Bagli, GHS, Jogipur, GSSS, Matour, GSSS, Rajol Distt. Kangra against longer stay or by clubbing their previous stay. The case was listed before the Hon'ble High Court of H.P. on 10.01.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

*"The writ Petition is accordingly disposed of with the direction that the representation filed by the petitioner be decided by the Competent Authority in light of the averment made therein within a period of four weeks from today. Pending miscellaneous application(S), if any also stand disposed of accordingly."*

The petitioner i.e Smt. Sanjay Bala, TGT (Med.) was called for personal hearing but she did not appear in the scheduled date and time due to recent weather condition and snowfall in the area mentioned in her representation. She has submitted fresh representation to transfer her at GSSS, Kaned, GSSS, Bagli, GHS, Jogipur, GSSS, Matour, GSSS, Rajol Distt. Kangra against longer stayee or by clubbing their previous stay against longer stay or by clubbing their previous stay.

From the perusal of record, it is found that Smt. Sanjay Bala TGT (Med.) is working at GHS Jammuhar u/c Ludoo Distt. Chamba since 12.03.2019 and she has completed her normal tenure at present place of posting as per transfer policy. Moreover GHS, Jammuhar u/c Ludoo Distt. Chamba falls in sub cadre area.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Sanjay Bala, TGT (Med.) is considered

sympathetically and petitioner is hereby transferred from GHS, Jammuhar u/c Ludoo Distt. Chamba to GSSS, Kaned Distt. Kangra vice Smt. Alka Mahajan TGT (Med.) (By clubbing her previous stay) with TTA/JT to Smt. Alka Mahajan. Keeping in view the position stated above, representation of the petitioner i.e Smt. Sanjay Bala, TGT (Med.) is disposed of accordingly.
