Whereas, Virender Singh, TGT (NM) presently working in GSSS Kotgarh, Distt. Shimla has filed CWP. No. 15519/2025- titled as Virender Singh, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Bilaspur/Mandi. The case of the petitioner was listed before the Hon'ble High Court on 25.09.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"4. Since it is quite apparent from the pleadings as well as documents adduced on record that petitioner has already completed normal tenure at present place of posting, this Court sees no reason to interfere with the impugned transfer order and as such, same is upheld. However, having taken note of the fact that wife of the petitioner is also working in the same department and at present, she is working as Language Teacher at GSSS Sikroha, District Bilaspur, Himachal Pradesh, coupled with the fact that recently certain posts of TGT's are lying vacant, as detailed in para 10 of the petition, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation of the petitioner expeditiously, preferably within a period of two weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy formulated by the Government of Himachal Pradesh. Pending applications, if any, stand disposed of"

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 30.10.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GMS Kuthera-Marahana u/c GSSS Bharan Bilaspur or GSSS Malyawar or GSSS Kapahara or GSSS Jukhala or GHS Deleg or GMS Talwara u/c GSSS Chandesh or GHS Kuthera (Mehrana) u/c Bharari or GSSS Jukhala, Distt. Bilaspur/Mandi against vacant post.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Churari u/c GSSS Hawan, Distt. Bilaspur to GSSS Kotgarh, Distt. Shimla vice Sh. Besru Ram vide this office letter of even number dated 04.09.2025 with the prior approval of competent authority. As per information received in this office, the petitioner joined at the place of his posting in GSSS Kotgarh, Distt. Shimla on 17.09.2025 and having short stay. Therefore, keeping in view of postion stated above the representation made by the petitioner is not acceded to. The representation is disposed of accordingly.
