## OFFICE ORDER

Whereas, the petitioned Hardyal Singh, Lect. Pol. Science—is working at GSSS Loharghat (Solan) w.e.f. 19.04.2021 & completed his normal tenure. Feeling aggrieved he filed CWP No. 4901/2025 titled as Hardyal Singh vs State of H.P.before the Hon'ble High court. This petition was listed before Hon'ble High Court on dated 03.04.2025 when the same was filnally disposed with the directions to respondents as under.

"Since, Petitioner has already completed normal tenure of posting at present place of posting, coupled with the fact that there is a provision in the Transfer Policy for consideration of request made by the petitioner on account on adverse family circumstances, this court without going into the case deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation (Annexure P-2) filed by the petitioner expeditiously, preferably within a period of four weeks from today. Ordered accordingly, needless to say, authority concerned, while doing the needful in terms of instant order, besides affording opportunity of being heard to the petitioners, shall also take note of provisions contained in Transfer Policy and pass appropriate orders. Pending applications, if any, stand disposed of."

And whereas, upon passing of above directions, petitioner has submitted his representation on dated 18.03.2025 vide which he has requested to adjust him at the choice of stations i.e. GSSS Amarpur (Bilaspur)/GSSS (G) Ghumarwin (Bilaspur) against vacancy on the medical ground of his old age mother who is more than 70 year old and she is heart patient besides she is taking regular treatment from IGMC Shimla. She is living alone at home and there is no one to take care of her. He is only son to take care of his mother. It has become very difficult to him to look after his sick mother at this feg end of her life and to manage his family affairs.

And whereas, that the matter has been examined and found that the post of Lect. Pol.Science lying vacant at Amarpur/(G) Ghumarwin (Bilaspur) but petitioner is posted in soft area and as per "Comprehensive Guiding Principles- 2013" for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience.

**Now therefore**, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected.

With these observations, representation stands disposed of.

Whereas, Sh. Vijay Kumar, Lect./Lect.(SN) Computer Science who is under orders of transfer from GSSS Kuthera (HMR) to GSSS Charna (Sirmour) againt vacancy in public interest vide this office order dated 31.07.2024, Vijay Kumar, Lect./Lect.(SN) Computer Science has filed CWP No.7784/2024 before the Hon'ble High Court against this transfer orders.

The case was listed before Hon'ble High Court on 28.03.2025 when the case was disposed of with the following directions:-

"Petitioner's incumbency position and distance between stations where he served, as placed on record by the respondents, clearly makes out that petitioner has been serving within a radius of 15 Kilometers in Distt Hamirpur w.e.f 17.10.2018 till date. As such, he has completed more than six years as on date within a radius of 15 km and , therefore, petitioner's contention that he has not been allowed to Complete normal tenure at one place cannot be ignored that his present transfer to GSSS Charna (SMR) is on the basis of D.O. note, therefore this writ petition is disposed of with direction of respondent No. 2 to take a fresh call in the matter of transfer of petitioner and issue appropriate orders in that regard in accordance with law as per applicable transfer policy within two weeks.

Till such period, petitioner shall be allowed to remain at the station petition stand disposed of in the aforesaid terms, so also the pending miscellaneous applications if any.".

And whereas, upon passing of above directions, As per direction of Hon'ble High Court, petitioner has submitted his representation on dated 17.04.2025 along with choice of stations that is:-

- Petitioner has request to cancel his transfer orders dated 31.07.2024 as he is not completed his normal tenure at present place of posting.
- 2. GSSS Samirpur (HMR) against vacancy.
- 3. GSSS Alampur (KGR) vice Sh. Vijay Kumar Lect. Computer Science who may further be transferred to GSSS Kuthera (HMR) against resultant vacancy (on consent basis).
- 4. GSSS Kakkiar (HMR) against vacancy.
- 5. GSSS (B) Hamipur (HMR) against vacancy.

And whereas, as per direction passed by the Hon'ble High Court as above, while examined his representation it is found that one outsource faculties is also working in GSSS Kuthera (Hamirpur) and student enrollment is 89. But the post of Lect. (SN) Computer Science is lying vacant at GSSS Charna (Sirmour) and no outsource faculity—is working there and enrollment of student is 30. However, and as per "Comprehensive Guiding Principles- 2013" for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience.

**Now therefore**, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected and his transfer orders dated 31.07.2024 shall stand.

With these observations, representation stands disposed of
