CWP No. 4124/2025- titled as Rajeev Kumar, TGT (NM), Vs. State of H.P. and others.

Whereas, Rajeev Kumar, TGT (NM) presently working in GMS Kando Cheyog, u/c GSSS Jamna, Distt. Sirmour has filed CWP. No. 4124/2025- titled as Rajeev Kumar, TGT (NM), Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Kando Cheyog, u/c GSSS Jamna, Distt. Sirmour to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 23.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"4. In view of petitioner's submission that the petitioner is interested to make a fresh representation on account of vacancies to be caused due to promotions in near future, this writ petition is disposed of by permitting the petitioner to make a fresh representation to the respondent No.2 /Competent Authority, who shall consider and decide the same, in accordance with law and applicable transfer policy within a period of two weeks from receipt thereof. The decision so taken, be communicated to the petitioner. Pending miscellaneous application(s), if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Kando Cheyog, u/c GSSS Jamna, Distt. Sirmour to GSSS Bhalaad or GMS Kaldnyan or GSSS Gangath or GSSS Chalwara or GSSS Behi pathyar or GSSS Maira or GSSS Rihan (Boys) or GHS Haryan Distt. Kangra against longer stayee or against vacancy being caused due to upcoming promotion of TGTs to Lecturer/Headmaster.

After perusal of the relevant record, it is revealed that the petitioner has been working in GMS Kando Cheyog, u/c GSSS Jamna, Distt. Sirmour since 25.02.2021. Though the said teacher has completed his normal tenure of three years at GMS Kando Cheyog, u/c GSSS Jamna, Distt. Sirmour but at present vacancies are not avalable in the above mentioned schools where petioner requested for transfer. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
