OFFICE ORDER

In the matter of: CWP No. 2909/2026-titled as Santosh Rani, Vs. State of H.P &Others.

Whereas, Smt. Santosh Rani, Lect. Math preferred CWP No. 2909/2026 titled as Santosh Rani, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Chango, Distt. Kinnaur to nearby Solan, Distt. Solan, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 13-03-2026 when the Hon'ble High Court has passed the following orders:-

3. "Accordingly, as prayed for, this petition is disposed of with the direction that let representation (Annexure P-1) of the petitioner be decided by the Competent Authority, in the light of the averments contained therein, by passing a speaking order, within a period of 12 weeks' from today, in accordance with law. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 24-03-2026. She attended the same and submitted her representation in this office, vide which She has requested that She may be transferred from GSSS Chango, Distt. Kinnaur to GSSS Guggaghat, Distt. Solan, against vacancy being caused due to retirement of present incumbent on 30-04-2026.

In the perusal of the record, it is found that the petitioner is working at GSSS Chango, Distt. Kinnaur, H.P. since 2010, which is tribal area and has completed her normal tenure at her present place of posting. One post of Lect. Math is going to be vacant due to retirement of present incumbent on 30-04-2026 at GSSS Guggaghat, Distt. Solan, H.P. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and She is hereby transferred without TTA/JT from GSSS Chango, Distt. Kinnaur to GSSS Guggaghat, Distt. Solan, H.P. against vacancy being caused due to retirement of present incumbent on 30-04-2026. These orders will be implemented after the retirement of present incumbent on 30.04.2026. The representation of the petitioner is disposed of accordingly.
