ORDER

The petitioner has filed present CWP No. 13890 of 2025 in the Hon'ble High Court vide which sought her transfer at one of the station of her choice i.e GMS Tanyur u/c GSSS Dhanather. The present CWP was listed before the Hor ble High Court of H.P. on 29.08.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 25-09-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Sohan Lal, TGT (Arts), has submitted fresh representation and stated that he is working at GSSS Gullarwala, Distt. Solan and going to retire on 31.01.2027 so that requested for transfer/adjustment at GHS Salnoo u/c GSSS Kandrour, GSSS Raghunathpura, GSSS Dhanather Distt. Bilaspur.

From the perusal of record, it is found that Sh. Sohan Lal, TGT (Arts) is working at GSSS Gullarwala, Distt. Solan since 10.08.2021 and has completed his normal tenure. Further the institution GSSS Gullarwala, is situtated in a soft area of District Solan, wherein 196 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right."

Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected on the grounds that the petitioner is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GSSS Gullarwala, Distt. Solan. It is further considered that the transfer of the petitioner at this stage would adversely affect the studies of the students during the mid-academic session. Hence, in view of the aforesaid facts and circumstances, the representation of the petitioner is rejected and stands disposed of. All the concerned are intimated accordingly.
