APPOINTMENT TO THE POST OF CHAIRPERSON AND ONE POST OF MEMBER IN HIMACHAL PRADESH PRIVATE EDUCATIONAL INSTITUTIONS REGULATORY COMMISSION, SHIMLA.

1. In continuation of the earlier advertisement No. EDN-A-Kha(4)-1/2020 dated 13th March, 2024, Application (s) are invited for filling up of vacant post of Chairperson and one post of Member in Himachal Pradesh Private Educational Institutions Regulatory Commission, Shimla as per provisions of Section 4 of the Himachal Pradesh Educational Institutions (Regulatory Commission) Act, 2010. The Chairperson/ Member should be a person of eminence in public life **or** in the field of higher education **or** who has remained Secretary **or** above to the Government of Himachal Pradesh **or** held equivalent post in Govt. of India for a period of three years or more. As per provision of the act *ibid* the Chairperson and the Member shall not be from the same field of specialization. Chairperson/Member of the Commission shall be appointed by the State Government for a period of three years **or** until he/she attains the age of 65 years, whichever is earlier. Such Chairperson/Member may be eligible for a second term subject to the upper age limit of 65 years. After the expiry of the term of office, the Chairperson/Member shall be ineligible for further employment **or** any assignment as per provisions contained in Section 4 of the Act *ibid*, in any of the Private Educational Institutions within Himachal Pradesh **or** their associate offices **or** companies within or outside Himachal Pradesh for a period of three years.
2. Eligible and interested candidates can send their application/ Bio-data for the post of Chairperson/ Member, Himachal Pradesh Private Educational Institutions Regulatory Commission by post or can deliver by hand at the following address on or before 28.04.2025 (5PM).
