Sir/ Madam,

The ACRs / ICs of following Radiographers for the last three years i. e. 2022-23,2023-24 and 2024-25, latest registration/renewal certificate of HP State Allied Health Care Council (HPPMC) alongwith Seniority number, present place of posting of Radiographer are required for promotion to the post of Sr. Radiographer as per final seniority list as it stood on 31.12.2024 mentioned below and also available on Departmental website www.hphealth.nic.in.

Before sending the ACR's all are requested to take due care about name of candidate, category, Date of Birth and Seniority as per Final Seniority List as it stood on 31.12.2024 to avoid future -representations. You are also requested to send the staff position i.e Sanctioned, in position, vacant & surplus (if any) of Sr. Radiographer of your Districts to enable this office to hold DPC.

It also indicated that a person having a valid certificate of benchmark disability would be eligible for the benefit of reservation amongst the Radiographers who possess five years regular services or regular combined with continues adhoc service rendered, if any, in the grade , however, no benefit of reservation would be given on the basis of a temporary certificate of disability.
