Sir,

Under NRHM, Government of India has launched "Janani Shishu Suraksha Karyakram (JSSK)" from Mewat district in Haryana on 1<sup>st</sup> June, 2011. Similarly, Himachal Pradesh has already launched Matri Sewa Yojna w.e.f. 15<sup>th</sup> August, 2010 and recently on 15<sup>th</sup> August, 2011, Hon'ble Chief Minister of Himachal Pradesh has announced Free treatment to all Children upto 1 yr. of age.

It invokes a new approach to healthcare, placing, for the first time, utmost emphasis on entitlements and elimination of out-of-pocket expenses for both pregnant women and sick infants.

**"Assures NIL out of pocket expenses in all Government Health Institutions"**

**Entitlements for Pregnant Women under JSSK**

- Free delivery
- Free caesarean section
- Free drugs and consumables
- Free diagnostics (Blood, Urine tests and Ultrasonography etc.)
- Free diet during stay (upto 3 days for normal delivery and 7 days for caesarean section).
- Free provision of blood
- Free transport from home to health institution, between health institutions in case of referrals and drop back home.
- Exemption from all kinds of user charges.

**Entitlements for Sick Children upto 1 yr. after birth**

- Free and zero expense treatment
- Free drugs & consumables
- Free diagnostics
- Free provision of blood
- Free transport from home to health institution, between health institutions in case of referrals and drop back home.
- Exemption from all kinds of user charges.

You are requested to convey these instructions to all the subordinate offices in your district as these instructions are to be implemented in the state w.e.f. 1<sup>st</sup> September, 2011.
