

Essential Qualifications for post of Chairperson of HP State Commission for Protection of Child


Rights:

- 1) A person should not have attained the age of 65 years.
- 2) Should be a person of eminence and should have done outstanding work for promoting the welfare of children.
3. Chairperson shall hold office for a term of 03 years from the date on which he/she assumes office. A person who has held the office of Chairperson shall be eligible for re-nomination. A person who has held the office of a Member shall be eligible for re-nomination as a member or nomination as a Chairperson
[Provided that a person who has held an office of Chairperson or Member for two terms, either whole or part, in any capacity, shall not be eligible for re-appointment at Chairperson or Member, as the case may be.]
[Provided that a person who has held office for two terms as Member or two terms as Chairperson, shall not be eligible for re-nomination as Chairperson;
Provided further that a person who has held office:-
 - i) For two terms as Member; or
 - ii) One term as a Member and one term as Chairperson shall be eligible for one more term as Chairperson.]
4. Note:- No person shall be considered for appointment as Chairperson of the HP State Commission for Protection of Child Rights, if he/she is adjudged as:-
 - a) Insolvent; or
 - b) Is of unsound mind and stands so declared by a competent court; or
 - c) Is convicted and sentenced to imprisonment for an offence which in the opinion of the Government involves moral turpitude.

N.B. Applicants are advised to submit an undertaking in " Affidavit Form" as per Rule-3 of the HP State Commission for Protection of Child Rights Rules- 2015 alongwith the Application Form on the following points:-

1. Having no past record of violation of Human Rights or Child Rights;
2. Having an experience at least five years of work in the field of Child Rights, Child Protection and advocacy for upholding the Rights of Children.
3. Not be an office bearer or a member of any Political Party.
4. Not hold any other post or be officiated to any Governmental, Semi Governmental, Public Sector Undertaking, Private Organization or hold any other position which provides benefit whether in cash or in kind

Qualifications for post of Members of HP State Commission for Protection of Child


Points:

- 1) A person should not have attained the age of 60 years.
- 2) Person of eminence, ability, integrity, standing and experience in:-
 - a) Education
 - b) Child Health Care, welfare or Child Development
 - c) Juvenile Justice or Care of neglected or Marginalized children or children with disabilities;
 - d) Elimination of child labour or children in distress;
 - e) Child Psychology or Sociology; and
 - f) Laws relating to children.
3. Every Member shall hold office for a term of 03 years from the date on which he/she assumes office. A person who has held the office of a Member shall be eligible for re-nomination as a Member.
[Provided that a person who has held office for two terms as Member shall not be eligible for re-nomination as a Member.]
[Provided that a person who has held an office of Chairperson or Member for two terms, either whole or part, in any capacity, shall not be eligible for re-appointment at Chairperson or Member, as the case may be.]
- 4 Note:- No person shall be considered for appointment as a Member of the HP State Commission for Protection of Child Rights, if he/she is adjudged as:-
 - a) Insolvent; or
 - b) Is of unsound mind and stands so declared by a competent court; or
 - c) Is convicted and sentenced to imprisonment for an offence which in the opinion of the Government involves moral turpitude.

N.B. Applicants are advised to submit an undertaking in " Affidavit Form" as per Rule-3 of the HP State Commission for Protection of Child Rights Rules- 2015 alongwith the Application Form on the following points:-

1. Having no past record of violation of Human Rights or Child Rights;


ENTITLEMENTS:-

(A) CHAIRPERSON

- a) He /she shall be entitled for an honorarium of ₹ 3000/- per sitting subject to maximum of ₹ 45000/- per month. In case, the Chairperson of the Commission is appointed amongst the retired government employees, he/she will be entitled for an honorarium at par with last pay drawn minus (-) pension.
- b) He/she shall be entitled for official vehicle.
- c) He/she shall be entitled for TA/DA as admissible to Secretary to the Government of Himachal Pradesh.
- d) He/she shall be entitled for Telephone facilities as admissible to Secretary to the Government of Himachal Pradesh.
- e) Free semi- furnished accommodation will be provided to the Chairperson or a uniform HRA @ 7200/- per month in lieu thereof.

(B) MEMBERS

- a) Each Member of the Commission shall be paid a sitting fee of ₹ 2000/- only per sitting and the maximum number of sitting per month are fixed at 15 sitting per month.
- b) Each Member shall be allowed use of Taxi at mileage rates fixed by the Government for travelling from their place of residence to Shimla i.e. Head Quarter of Commission subject to the condition that this mileage will be restricted to 3 round trips in a month.
