Sealed tenders are invited on proformas attached herewith (Annexures A to C) for **SUPPLY OF 11 (ELEVEN) MAHINDRA SCORPIO N- Z8S IN WHITE COLOUR (PETROL), FROM ORIGINAL EQUIPMENT MANUFACTURER (OEM)/ AUTHORIZED DEALERS** for use of ELEVEN DISTRICT LEGAL SERVICES AUTHORITIES (DLSAs) i.e., DLSA CHAMBA, BILASPUR, HAMIRPUR, KANGRA (at Dharamshala), KINNAUR (at Reckong-Peo), KULLU, MANDI, SHIMLA, SIRMAUR (at Nahan), SOLAN and UNA respectively IN HIMACHAL PRADESH and the vehicles are to be registered in Himachal Pradesh.

**A. Procedure for offline Submission of Tender Document**

The Tender for the above items are invited offline. The following procedure will be adopted for the offline opening of the price bids.

**Submission of the Bids:**

The bids will be submitted at our office with the following documents:

**Technical Bid**

1. Duly filled, signed & stamped tender document.
2. Original Equipment Manufacturer (OEM) certificate or authorized dealership/distributorship certificate, as applicable.
3. Detailed technical specifications highlighting the features of the vehicle.
4. Firms' Business Registration documents.
5. GST Registration number of the firm.
6. Tender fee, where applicable, should be in shape of Demand Draft of any nationalized/ scheduled bank in favour of the "MEMBER SECRETARY, HPSLSA, SHIMLA" payable at SHIMLA or may be paid as cash (under due receipt).

7. Earnest Money Deposit (EMD) should be in shape of NSC/Time Deposit/ electronic Bank Guaranty (e-BG)/Saving Bank account in the Post Office/bank in H.P./ Demand Draft of any nationalized/ scheduled bank. EMD should be duly pledged in favour of the “**MEMBER SECRETARY, HPSLSA, SHIMLA**” payable at SHIMLA.

**Mode of sending the tender:**

Two covers bid tender. Two separate envelopes consisting of technical bid (eligibility criteria) in one envelope and financial/commercial bid in another envelope. Both envelopes to be kept in main single envelope along with Demand Draft for the Tender Fee (₹ 1,000/- where applicable) and EMD (₹ 5,00,000/-) shall be submitted in sealed cover by registered speed post/Courier/by hand only.

**Exemption from submitting EMD:** It will be available for eligible bidders as per latest exemptions available under State/ Center Government Rules/Notifications on submission of requisite document of exemption.

**Refund of EMD:**

For Unsuccessful Bidders, EMD will be refunded/ returned on issuance of Purchase Order to the Successful Bidder, upon receipt of a written request, deducting necessary bank charges, if any and without any interest.

For the Successful Bidder, EMD will be refunded/ returned after satisfactory completion of work as mentioned in the Purchase Order upon receipt of a written request by the Successful Bidder after deducting necessary bank charges, if any, and without any interest.

**Description essential to be made on sealed cover:**

The main single envelope must be superscribed as “Tender for supply of 11 (ELEVEN) MAHINDRA SCORPIO N- Z 8 S IN WHITE COLOUR (PETROL)”.

**Two separate covers** superscribed as (1) Technical bid cover and (2) Commercial bid **to be kept in main single envelope along with tender fee and EMD.**

**(1) Part-1, Technical bid:** - This bid will be opened on **16.02.2026 at 3:00 PM** at the office of The Member Secretary, Himachal Pradesh, State Legal Services Authority, Shimla-171009 by the Committee constituted by the Member Secretary, Himachal Pradesh, State Legal Services Authority, Shimla in the presence of bidders or their authorized representatives, if they wish to be present.

**2) Part-2, Financial/commercial bid:** - This bid will be opened after the examination of pre-qualification and shall be opened for only those bidders who will succeed in technical Bid. The date and time of opening of Financial bid will be intimated accordingly through email.

**General Terms and Conditions:**

1. Only the manufacturer and their authorized distributors or dealers or channel partners having their dealership in Himachal Pradesh need to submit their tender. The authorized distributors or dealers or channel partners should furnish a certificate from the manufacturer for their dealership.
2. No person or firm shall be allowed to submit more than one Bid.
3. It is mandatory to provide all the relevant documents as per the Tender document.
4. The H.P State Legal Services Authority is a Govt. entity. Hence vehicles are applicable to Government passing (G- Passing). The procedure of G-passing shall be followed by the bidder.
5. The Tender/ Bid should be accompanied with the detailed printed technical literature with specifications, make and model number of each item. Specifications given in the offer must be similar to the information available on the website and/or printed technical literature, otherwise, the offer shall be rejected.
6. The Tender /Bid must provide a guarantee/warranty of satisfactory functioning of the vehicle for a period of at least two years from the date of purchase, alongwith the price of extended warranty for a period of further 05 years.
7. **Payment Terms:** The standard terms and conditions with regard to the payment would be treated as full and final at the time of delivery of the vehicles.
8. **The rates quoted should be strictly according to the Proforma annexure-A. The Rates should be F.O.R. O/o the Member Secretary, Himachal Pradesh, State Legal Services Authority, Shimla-171009.**

9. Please quote the maximum discounted price, as no further negotiations will be made.
10. **The Competent Authority shall have right to take any decision in the interest of Institution and also in the interest of Public without assigning any reason (s) thereof.**

**B. Terms and Conditions of Tender**

1. The Bidders are required to quote their lowest rates including Insurance Charges, Road Tax, Extended Warranty Charges and Maintenance Charges etc. for the above-mentioned **11 (ELEVEN) MAHINDRA SCORPIO N- Z 8 S IN WHITE COLOUR (PETROL)**”.
2. The rates should be valid for a minimum period of 40 days from the date of opening of tenders. The bidder shall not be entitled during the said period of 40 days to revoke or cancel its bid or to vary the bid or any terms thereof.
3. **The Vehicles are to be provided to the Procuring Authority on or before 10.03.2026.**
4. Hypothetical or conditional Bidders will not be entertained. Tender once submitted shall not be allowed to be withdrawn or altered otherwise, and if so, the appropriate action will be taken against that Bidder, as may be deemed fit by the Competent Authority. The Bidder shall be bound by the terms and conditions of the tender.
5. The HPSLSA will deal with the bidder directly and any middlemen/agents/ commission agents etc. will not be entertained by the Authority. The Tender Form is non-transferable and agency shall not be permitted to transfer its rights and obligations to any other person/organization or otherwise.
6. Over-writing/over-typing or erasing of the figures which render it doubtful or ambiguous are not allowed and shall render the bid invalid.
7. The bidder shall give an undertaking **(as per ANNEXURE-B)** that the Firm/Partner/Director/Proprietor has not been blacklisted and its business dealings with Central/State Government/Public Sector Units/autonomous bodies have not been banned/terminated on the account of poor Performance.
8. The Competent Authority, in its discretion, reserves the right to make any change, any time, in the terms and conditions of the Tender and accept or reject any or all the Bids, wholly or completely, without assigning any reason thereof at any stage of tendering process.
9. **The bidder shall quote rates both in figures and words with blue/black ball pen.** In case of any discrepancy, the figures mentioned in words will be considered.

10. The bidder should specifically mention whether rates are inclusive of GST or CESS (as applicable) and if it is not mentioned, it will be presumed that rates are inclusive of GST or CESS.
11. All the pages of quotations including the documents submitted therein must be duly signed and stamped failing which the Bid shall be liable for rejection.
12. This Authority is not bound to accept the rates submitted by the lowest bidder or any other bidder nor does it undertake to assign any reasons for its decision in this matter.
13. Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates or violates any terms and conditions of tender, the EMD shall be forfeited and Bid shall be rejected.
14. The supply of **11 (ELEVEN) MAHINDRA SCORPIO N-Z 8 S IN WHITE COLOUR (PETROL)** will be inspected by Inspection Committee of Senior Officers of this AUTHORITY and in case, the supply is not found in conformity with the approved specifications, the same is to be replaced exactly commensurate with approved specification at the cost of the bidder. The decision of the Committee in this regard shall be final.
15. The payment will be made only after the delivery of Vehicles, if the same are acceptable as per approved specification.

#### **C. Terms and Conditions for successful Bidder**

1. The successful bidder shall be responsible for getting the HP Number Plate, accessories, etc. affixed on the vehicles, after the delivery of the vehicle and at Shimla, H.P. at its own cost.
2. Successful bidder has to submit Performance Security as per rules.
3. The successful bidder will have to abide by the terms and conditions as may be fixed from time to time by the Authority.
4. The tender should accompany an undertaking of Authenticity as per the Proforma placed at **ANNEXURE-C.**

#### **D. Penalties**

1. **The delivery of Eleven vehicles shall be required to be made on or before 10<sup>th</sup> March, 2026** and in case supply is not received within the stipulated time and the Authority is forced to make a purchase/ hire to meet the urgent demand, the loss, if any, would be recovered from the bidder.
2. Irrespective of the fact as to whether or not the Authority may impose penalty of 1% per month subject to a maximum of 10% of the total cost, for delayed delivery, if the delay is caused due to

willful laches or negligence of the bidder and it resulting into financial loss or inconvenience to the Authority.

E. In case of any dispute, the decision of the Hon'ble Executive Chairman, HPSLSA, Shimla shall be final and binding upon all.
