## OFFICE MEMORANDUM

The Undersigned is directed to say that as per existing practice, regular class-IV employees and work-charged staff are entitled to livery articles plus Washing Allowance @ Rs.30/- per month for the performance of their official duties. It has been brought to the notice of the Government that despite the explicit provisions in the rules for providing of uniforms to Class-IV employees of the Government, uniforms are not being received by the employees in some offices within the prescribed time limit owing to the cumbersome procedure being followed in finalizing the process of quotations and selection of such articles. This had been a persistent demand of the employees unions to dispense with the existing system of providing of the liveries and to grant them a fixed allowance in lieu of liveries. Accordingly, the matter relating to grant of uniform allowance in place of livery articles to the Class-IV employees has been under consideration of the Government for some time past. After thoughtful consideration of the matter, the Governor, Himachal Pradesh is pleased to order that a fixed allowance in the shape of "Uniform Allowance" @ Rs.140/- per month inclusive of Washing Allowance, stitching charges and other admissible sundries, if any, will be granted to all class-IV employees who are presently entitled for liveries w.e.f. 1.4.2002.

- The employees who are posted on security duties like (Gate-Keepers) and staff posted in High Court/Courts/Governor Secretariat and H.P. Vidhan Sabha and Class-IV staff posted in Hospitals and the offices where wearing of Uniforms is necessary will continue to get liveries as per existing practice. Therefore, the above allowance will not be admissible to these employees.
  - 3. It may be ensured by the head of office that the Class-IV employees under their control wear the prescribed

uniforms during office hours duly stitched by themselves failing which suitable action be taken against them.

- 4. The arrears accrued from 1.4.2002 onwards may be paid in cash.
- 5. These orders may be brought to the notice of all concerned for strict compliance.
- 6. The Orders of entitlement of liveries to Class-IV employees, issued from time to time and contained in Appendix-12 of H.P. Financial Rules, 1971, Vol-II shall be deemed to have been modified to above extent.
